ORDER:

In pursuance of the judgment of Hon'ble Supreme Court of India dated. 12-8-2005 in Appeal (civil) No. 5041 of 2005 filed by P.A. Inamdar Vs. State of Maharashtra (AIR 2005 SC 3226), the judgment of Hon'ble Supreme Court of India, dated 09.05.2017 in Dar-us-Salam Educational Trust and Ors (Writ Petition(s) (Civil) No(s). 267/2017) and the discussions held with the Private Unaided Medical and Dental Colleges in the State for admission into the Under Graduate Courses i.e., MBBS & BDS, a consensual arrangement has been arrived at in adopting the admission policy, and seat matrix for the Competent Authority seats, National Eligibility Cum Entrance Test (NEET) ranking based Management seats, NRI/ NRI sponsored seats in Unaided Minority Medical and Dental Colleges in the State.

2. The Government after careful examination have decided to amend the Andhra Pradesh Un-aided Minority Professional Institutions (Regulations of Admissions into Under Graduate Medical and Dental Professional Courses) Rules 2006, issued in G.O.Ms No. 272, HM&FW (E1) Deptt Dt. 10.07.2006, and as amended subsequently.

3. Accordingly, the following notification shall be published in the Extraordinary issue of the Andhra Pradesh Gazette, Dated:27.07.2017

NOTIFICATION

In exercise of the powers conferred by Sections 3 and 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (A.P. Act No. 5 of 1983) and in partial modification of the Andhra Pradesh Un-aided Minority Professional Institutions (Regulations of Admissions into Under Graduate Medical and Dental Professional Courses) Rules, 2006 issued in G.O.Ms No. 272, HM&FW(E1) Deptt. Dt. 10.07.2006 and published in the extraordinary issue of A.P. Gazette dated.12.07.2006.

AMENDMENTS

In the said rules,

1. In Rule 1 (ii), the word "EAMCET" shall be substituted with "National Eligibility cum Entrance Test (NEET)-UG".
2. The Rule 2 (i) (b), shall be substituted with "Common Entrance Test" means National Eligibility cum Entrance Test (NEET)-UG the examination conducted for assigning rank to candidates which will be the basis for admission of the candidates into NEET-UG ranking based Management Seats etc., for the first year of under – Graduate Course concerned in various Un-aided Minority Professional Institutions in the State.
3. The Rule 2 (i) (c), shall be substituted with "NEET-UG ranking based Management Seats for Minority Candidates" means the seats earmarked from out of the sanctioned intake of the seats in each course and in each college with the Minority Students on the basis of NEET merit".
4. The Rule 2 (i) (g), shall be substituted with "Qualified candidate in respect of seats to be filled by NEET-UG ranking based Management (Minority) seats" means the candidate who has appeared the National Eligibility cum Entrance Test (NEET)-UG held by the Government of India for admission into the related Professional Course and secured cut off percentile prescribed for that category.

2. After Rule 2 (1) (h), the following shall be added:

- (i) "Competent Authority" means the Vice-Chancellor, Dr. NTR University of Health Sciences, Vijayawada.
- (ii) "Committee for admissions" means the committee constituted by the Competent Authority to select and make allotment of candidates to Un-aided Minority Professional institutions offering Medical and Dental courses in the State for admissions in accordance with the provisions laid down".

3. In the Rule 3 (c), the word "EAMCET" shall be Substituted with "NEET-UG".

4. For Rule 6 (a), the following shall be substituted :-

(a) To fill up NEET based Minority Seats:

Category - A seats (50% of the sanctioned intake of the seats)

- i. Committee for admissions shall be constituted by the Competent Authority under these rules.
- ii. The Competent Authority shall issue an advertisement calling for a single application in the prescribed form from the eligible qualified candidates who have secured minimum percentile prescribed for that category in the Common Entrance Test, seeking admission in Private Un-aided Minority Professional Colleges.
- iii. The candidates who are qualified securing minimum percentile prescribed in the Common Entrance Test and desires of seeking admission into the Private Un-aided Minority Professional Colleges. Shall make application to the Committee for Admissions in response to their notification.
- iv. The candidates have to get their certificates verified as per schedule notified by Committee for Admissions.
- v. The merit order will be displayed by Committee for Admissions after verification of all original certificates.
- vi. The selection of candidates and allotment of course / institution in respect of the seats shall be solely on the basis of merit as adjudged in

- the Entrance Test subject to the condition that the candidate should have passed the qualifying examination with the minimum marks prescribed.
- vii. The seats in Category- A shall be filled with eligible Minority candidates. If no eligible Minority candidates are available even after final counseling, then the unfilled seats shall be converted to unreserved and filled with eligible Minority candidates. Even then also no eligible Minority candidates available, the seats will be filled with other than Minority candidates by order of merit.
 - viii. Mere appearance at the Entrance Test and obtaining high rank in the merit list does not entitle a candidate to be considered for admission automatically into any course / institution unless he/she also satisfies the rules and regulations of admission prescribed by the concerned University / Government including marks to be obtained in the qualifying examination etc.
 - ix. The Committee of admissions shall select and allot candidates into various courses as per merit.
 - x. Request for a change to any other category after display of final merit list shall not be considered.
 - xi. The Committee for Admissions shall have the power to cancel the selection or admission of the candidates at any stage if it is detected either during selection or before closure of admissions that the selection or admission is against the regulation.
 - xii. The Competent Authority / Committee for admissions shall prepare the final list of candidates, admitted course wise and to send the same to the University.
 - xiii. The Competent Authority in consultation with Committee for admission shall fix the cut off dates for each stage of admission contemplated above
