I am by direction to inform that, the Phase-I of web counselling for Management Quota seats in Private Un-aided Non-Minority BHMS seats is completed on **10-02-2023** and candidates have to report at the respective AYUSH Colleges on or before **10.00 AM on 13-02-2023**.College wise allotted list of is placed in the University website <u>http://drntruhs.in</u>

Keeping in view of the limited time schedule as per AACCC/NCISM, New Delhi all the Principals concerned are requested to treat Saturdays/Sundays as working days.

In this connection, I am to inform you that, this University has verified the uploaded scanned copies of the candidates for Management Quota seats in Private Un-aided Non-Minority UG AYUSH (BHMS) admissions. The Original certificates of the candidates were not verified by the University.

In this regard you are directed to constitute a "Committee" consisting of 2 or 3 Professors and Principal as chairman of the Committee to verify the Original certificates of the Candidates before completing the process of admission. All the Original certificates must be verified very carefully and any discrepancies must be brought to the notice of University immediately.

The "Committee" to be constituted at the colleges, shall arrange for the verification of all the Original certificates of the candidates as University has verified only the scanned and uploaded documents. Any deviation should be brought to the University notice immediately.

The list of documents to be verified at the time of admission is enclosed.

	counselling for admission to UG (BAMS/BUMS/BHMS) courses under
	State Quota/UT Quota/Institutional Quota/Central pool Quota/AIQ
	(Private Institute) etc. for the academic year 2022-23 as notified vide
	Lr.No.14030/85/2022-EP-1, dt.19-01-2023 of AACCC, Ministry of
	AYUSH, New Delhi.
3.	Reported candidates who have not opted to free exit from the allotted AIQ
	Private un-aided Non- Minority UG AYUSH (BHMS) counselling are not
	eligible to participate in this counselling.
4.	The selected candidates can download the provisional allotment order on
	payment of University Registration Fee through payment gateway and
	report to the Principal of the allotted college on or before the date
	specified in the allotment order.
5.	UNIVERSITY FEE: The selected Candidates have to download the
	allotment order by pay Rs.20,100/- before obtaining allotment letter
	through payment Gateway by using Online payment method. (Debit Card
	/ Credit Card / Internet Banking) and report to the Principal of allotted
	college along with the allotment order and original certificates before the
	date specified in the order and pay the prescribed tuition fee at college.
6.	TUITION FEE FOR UG AYUSH COURSES: The selected candidates
	have to pay tuition fee of Rs.3,00,000/- per year for admission into
	Management Quota seats in Private UG AYUSH (BHMS) Courses in Un-
	aided, Non-Minority UG AYUSH Colleges as per orders of Government
	of Andhra Pradesh G.O.Ms.No.159 HM& FW (C2) Dept., dt.23.12.2020
	& G.O.Ms.No.14 HM& FW (C1) Dept., dt.09.02.2021.
7.	The University fee and other fee once paid shall not be refunded under
	any circumstance.

8.	The selected candidates have to submit all the original certificates, pay
	the Tuition fee, and complete the process of admission. If the candidate
	does not fulfil the above criteria to complete the admission process in the
	specified dates of admission, their admission will be cancelled
	automatically.
9.	The verification of original certificates will be conducted at the time of
	admission in the respective college and in case of any discrepancy, the
	Provisional allotment will be cancelled and action will be initiated. It the
	candidate slides to other college (i.e., affiliated colleges of Dr.YSR UHS)
	during subsequent phases of counselling, the original certificates will be
	sent to the college concerned by the college where the candidate has
	slide.
10.	After the cutoff date for reporting i.e., by 10.00 AM on 13-02-2023, no
	candidate should be admitted and their Provisional admission is deemed to be
	cancelled without any further intimation.
