I am by direction to inform that, the Mop Up counselling for PG AYUSH i.e., MD/MS(Ayurveda) seats are completed and candidates have to report at the College on or before **03.00 PM on 31-03-2023.** College wise allotted list is placed in the University website <a href="http://drntruhs.in">http://drntruhs.in</a>

In this connection, I am to inform you that, this University has verified the uploaded scanned copies of certificates of the candidates for PG AYUSH MD/MS(Ayurveda) admissions. The Original certificates of the candidates were not verified by the University.

In this regard you are directed to constitute a "Committee" consisting of 2 or 3 Professors and Principal as chairman of the Committee shall arrange to verify the Original certificates of the Candidates before completing the process of admission. All the Original certificates must be verified very carefully and any discrepancies must be brought to the notice of University immediately.

The "Committee" to be constituted at the colleges, shall verify the Original certificates of the candidates as University has verified only the scanned and uploaded documents. Any deviation should be brought to the University notice immediately.

The list of documents to be verified at the time of admission is specified vide Annexure- I and please follow the instructions given vide Annexure – II.

#### **Instructions: -**

- 1. The candidates MD/MS (Ayurveda) who have already got admission through AIQ counseling of AACCC, New Delhi are not eligible to participate in this counselling vide Ref.L-14030/137/2022-EP-1, dt.17.03.2023. If it is found that the ineligible candidate participated in this counseling, candidature of such candidate will be cancelled without intimation.
- 2. The candidates who were allotted seat in Phase-I & Phase-II/Final counseling are not eligible to participate in this MOUPUP Round Counseling.

- 3. The candidates who get allotment in this Mop Up round Counseling should compulsorily join in the allotted college.
- 4. Candidates will receive the allotment order after allotment of seat, if seat is allotted. The candidates are also instructed to visit the **website:** <a href="https://pgayurveda.ntruhsadmissions.com">https://pgayurveda.ntruhsadmissions.com</a> for status of allotment.
- 5. Candidate can download the provisional allotment order on payment of University Fee through payment gateway.
- 6. Candidates are informed to check their Mop Up allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
- 7. The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated.
- 8. The University fee once paid shall not be refunded under any circumstances.
- 9. As per G.O. Ms No.13, HM & FW (F2) Dept., dt. 05.02.2021, If any candidate wish to discontinue their course, after closure of the admission (or) during the course of period should pay of Rs. 50000/-+9000/-@18% GST (Rupees fifty Nine thousand only) in the form of DD drawn in favour of the Registrar, Dr.YSR University of Health Sciences, A.P., Vijayawada.
- 10. After the cutoff date for reporting i.e., by **03.00 PM on 31-03-2023**, no candidate should be admitted and their Provisional admission is deemed to be cancelled without any further intimation.
- 11. Principals have to upload the Report/Not Reported data in the Website <a href="https://pg.ntruhsadmissions.com/principal\_login/login\_by\_04.00">https://pg.ntruhsadmissions.com/principal\_login/login\_by\_04.00</a> PM on 31-03-2023.
