Candidates can exercise any number of options for any number of subjects and colleges if the candidate is really interested to join that particular speciality in a particular college as per eligibility. | | | |
| 3 | Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are really interested. If they are not interested to join any subject or college then they should not exercise options for the same. | | | |
| 4 | Candidate can exercise web options from any place having internet facility. One Time Password will be sent to the registered mobile number at the time of saving Web options. | | | |
| | I) Selected Options can be slided either up or down, added and deleted. II) Web options opted must be saved by the candidate. III) Web options once submitted can not be Edited. IV) Web options saved but not submitted until the cut off date and time will be Auto submitted. | | | |
| 5 | The selected candidates can download the provisional allotment order on payment of University Fee of Rs.49,600/- through payment gateway and report to the Principal of the Allotted College on or before the date specified in the allotment order. This University fee is not refundable under any circumstances. | | | |
| 6 | The selected candidates shall produce all the Original certificates, pay the Tuition fee, necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the criteria as per regulations to complete the admission process in the specified dates of admission, their admission will be cancelled automatically. | | | |
| 7 | The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr.NTR UHS) during subsequent Phases of counselling, the original certificates and tuition fee will be sent to the slided college by the concerned college | | | |

- Note:1. As per the Notice No.U-12021/01/2022-MEC, dt.12-07-2022 of DGHS, HM&FW Govt. of India, New Delhi, the joined candidates up to round 2 of AIQ or State Quota shall not be eligible to participate in the further rounds for All India Quota or for State Quota from the academic year 2022-23 onwards.
 - 2. In this Phase-I counselling, if a candidate has not joined/reported in the allotted seat then that particular seat will not be available for that candidate to exercise web options in Phase-II of counselling.
 - 3. Next rounds of counselling (exercising web options) will be conducted for:
 - Unfilled seats in Phase-I

where the original certificates are present.

- Not reported/Not joined seats of Phase-I.
- 4. a) Candidates who have been allotted any seat in any Phase of counselling are not allowed to participate in the MoP Up Round.
 - b) Candidates already holding any seat at any place are also not eligible for MoP Up Round.

- If any candidate joins a seat allotted in Phase-I of State Quota/Competent Authority Quota seat in AP State can slide to a seat allotted in this Phase-I of Management Quota seat in AP State and in such case, the tuition fee already paid for the SQ/CQ will be returned to the candidate by the concerned college and the original certificates will be sent to the slided college by the concerned college where the original certificates are present.
- As per Notice Ref.U-12021/01/2022-MEC, dt.22-09-2022 of DGHS, Govt. of India, New Delhi OCI/PIO/Foreign Nationals will only be eligible for NRI seats and not for Indian (All India Quota/Central/Deemed paid (Indian) seats for the current academic year. For complete details refer Notice Ref.U-12021/01/2022-MEC, dt.22-09-2022 of DGHS, Govt. of India, New Delhi.

- a) If it is found at a later stage that, the candidate has concealed any information, legal action that deems fit as per Rules will be initiated without any intimation.
- b) Necessary undertaking to this effect shall be submitted at the allotted college where required verification will be carried out by the Principal concerned.
