I am to inform you that the Phase-II counselling for admissions into PG(Medical) courses of Management Quota seats is completed on **05-11-2022** and the allotted candidates have to report at the respective Medical Colleges on (or) before **04.00 PM on 07-11-2022**.

You are well aware of that, University has verified the uploaded scanned copies of the candidates for PG Medical admissions. The Original certificates of the candidates were not verified by the University.

In this regard you are directed to constitute a "Committee" consisting of 2 or 3 Professors and Principal as chairman of the Committee shall arrange to verify the Original certificates of the Candidates before completing the process of admission. All the Original certificates must be verified very carefully and any discrepancies must be brought to the notice of University immediately.

The "Committee" to be constituted at the colleges should verify the print out of Online Application form, Provisional Verification form and Original certificates of the candidates and any deviation should be brought to the University notice immediately. Please observe remarks if any on the provisional verification form before admitting the candidate.

The list of documents to be verified at the time of admission is specified vide Annexure-I and please follow the instructions given vide Annexure-II.

Further, I request you to freeze the data of Not Reported/Reported candidates by 05.00 P.M on 07-11-2022 duly following the instructions of the Service Provider.

- 2. The Principals are requested not to insist for Original certificates, fee, bonds etc., from the candidates slided from other colleges in AP. They are requested to admit those students with the allotment letter issued by the University and the relief letter and custodian certificate issued by the Principal of the college already joined.
- 3. While admitting the candidates joining afresh, please verify University Allotment Order (Please verify and confirm with the list in the University website), Application form and Provisional Verification Report. Please notice the remarks if any given in the Provisional Verification Report.
- 4. The Principals of the colleges where the candidates already joined in the Phase-I and now allotted a seat in another college in Phase-II are to be relieved by giving relieving order by e-mail/In person. The fee paid by the candidate must be transferred to the allotted college of the Phase-II counselling.
- 5. After the cutoff date for reporting i.e., by **04.00 PM on 07-11-2022**, no candidate should be admitted and their Provisional admission is deemed to be cancelled without any further intimation.
- 6. Principals have to upload the Reported/Not Reported data by **05.00 PM on 07-11-2022.**

- 8. ORDER:

The A.P. Higher Education Regulatory & Monitoring Commission (APHER&MC) in its meeting held on 24.5.2020 has resolved to determine thefee structure of the P.G. Courses for Medical and Dental Colleges (Non- Minority and Minority Institutions) in the State of A.P. for the Block Period 2020-21 to 2022-23. The Secretary & CEO, (APHER&MC) in his Letter read above, has furnished the minutes of the meeting of APHER&MC held on 24.5.2020 alongwith the recommendations regarding the fee structure for the P.G. Medical courses for all specialities in Private Un-aided Non-Minority and Minority colleges and P.G. Dental courses in Private un-aided Non- Minority colleges in the State of A.P. for the block period 2020-21 to 2022-23 and requested to issue necessary notification in the matter.

2. Government after careful examination of the matter, hereby issue the following Notification which shall be published in the A.P. Extra-ordinary Gazette:

NOTIFICATION

- 3. In exercise of the powers conferred under Section 7 of Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act,1983 (Act No.5 of 1983) the Government considered the fee structure recommended by the APHER&MC in their meeting held on 24.5.2020, determining the Fee structure per annum for the P.G. Medical courses for all specialities in Private Un-aided Non-Minority and Minority colleges and P.G. Dental courses in Private un-aided Non-Minority colleges in the State of A.P. for the block period 2020-21 to 2022-23.
- 4. On careful consideration, the Government of Andhra Pradesh hereby notify the Fee Structure for the P.G. Medical courses for all specialities in Private Un-aided Non-Minority and Minority colleges and P.G. Dental courses in Private Un-aided Non-Minority colleges in the State of Andhra Pradesh for the block period 2020-21 to 2022-23. The details of fee structure is annexed as Annexure-I and Annexure-II to this order respectively.

- 5. The above said fee structure notified by the Government under Section 7 of Act 5 of 1983 for the block period 2020-21 to 2022-23 is subject to the following conditions:
 - a. The fee is an all inclusive annual fee including various fees like tuition fee, admission fee, special fee, laboratory/library fee, computer/ internet fee, maintenance and amenities fee, extra curricular activities fee, development fee andother recurring expenditure.
 - b. The aforesaid fee determined for all the PG Medical courses and PG Dental Courses for the colleges mentioned in ANNEXURES I & II does not include hostel, transport, mess charges, etc.
 - C. The above fee structure for all the PG Medical Courses and PG Dental Courses as mentioned in Annexure-I & II, shall be applicable for the new courses / colleges mentionedduring the block period 2020-21 to 2022-23.
 - d. The institution shall collect the annual fee for every year in two half yearly instalments in advance.
 - e. The same fee shall continue for the students admitted during the block period of 2020-21 to 2022-23 till they complete the course.
 - f. The institution shall not charge either directly or indirectly any other amount over and above the fee fixed in theAnnexures. If any other amount is charged under any other head or guise i.e., donations, the same would amount to charging of capitation fee and are liable to be prosecuted under Section 9 of Act 5 of 1983 apart from imposing appropriate penalty under the APHERMC Rules.
 - g. Stipend shall be paid to the PG students on par with the students in the Government PG Medical and Dental Colleges.
 - h. In case of any deviation from these directions, the Commission will initiate serious penal consequences as per the Act and Rules made thereunder.
- 5. The Registrar, Dr.NTR University of Health Sciences, Vijayawada and the Principals of all the Private Non-Minority and Minority Medical/Dental Colleges shall take necessary action accordingly.
- 6. These orders are subject to directions/outcome of the court cases, pending if any and as per the guidelines/directions issued by MCI/DCI/GOI from time to time.
