Sub:- Dr.YSR UHS – ADMISSIONS – Phase-II/Final web based counseling for admission into the All India Quota seats in Private Un-aided UG AYUSH BHMS Colleges for the Academic year – 2022-23 – Certain instructions issued – Regarding.

I am by direction to inform that, the Phase-II/Final web counselling for All India Quota seats in Private Un-aided UG AYUSH BHMS seats is completed and candidates have to report at the respective AYUSH Colleges on or before **01.00 PM on 08.02-2023** College wise allotted list of is placed in the University website <u>http://ntruhs.ap.nic.in</u>

In this connection, I am to inform you that, this University has verified the uploaded scanned copies of the candidates for All India Quota seats in Private Un-aided AYUSH BHMS admissions. The Original certificates of the candidates were not verified by the University.

In this regard you are directed to constitute a "Committee" consisting of 2 or 3 Professors and Principal as chairman of the Committee to verify the Original certificates of the Candidates before completing the process of admission. All the Original certificates must be verified very carefully and any discrepancies must be brought to the notice of University immediately.

The "Committee" to be constituted at the colleges, shall arrange for the verification of all the Original certificates of the candidates as University has verified only the scanned and uploaded documents. Any deviation should be brought to the University notice immediately.

The list of documents to be verified at the time of admission is enclosed.

Instructions: -

1.	The candidates are instructed to visit the website:
	http://ugayushaiq.ntruhsadmissions.com/ for status of allotment.
2.	a. There are two rounds of counselling for All India Quota seats and
	after 2nd round, if AIQ seats are not filled, these seats will be
	converted into the state quota seats and will be filled up as per state
	Government rules.
	b. The Round 2 admitted candidates of AIQ Private UG Counselling
	can withdraw/surrender their admitted seat only on a specific date to
	be notified by Dr. YSR UHS, Vijayawada.
	c. After the said period, candidates will not be allowed to
	Withdraw/Surrender their admitted seat of Round-2. If they do so,
	they will be ineligible for any further AYUSH counselling conducted by
	Central/State/UT.
3.	The selected candidates can download the provisional allotment order
	on payment of University Registration Fee through payment gateway
	and report to the Principal of the allotted college on or before the date
	specified in the allotment order.
4.	UNIVERSITY FEE : Candidates to whom allotment message is given have to pay Rs.8600/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking).
5.	TUITION FEE FOR UG AYUSH COURSES : The selected candidates have to pay tuition fee of Rs.22,000/- per year at the allotted college for admission into AIQ seats in Private UG AYUSH (BHMS) Course in Un-aided, Non-Minority UG AYUSH Colleges as per orders of Government of Andhra Pradesh G.O.Ms.No.159 HM& FW (C2) Dept., dt.23.12.2020 & G.O.Ms.No.14 HM& FW (C1) Dept., dt.09.02.2021.
6.	The University fee and other fee once paid shall not be refunded under any circumstance.
7.	Commencement of Class from 20-02-2023.
8.	The selected candidates have to submit all the original certificates, pay
	the Tuition fee, and complete the process of admission. If the
	candidate does not fulfil the above criteria to complete the admission
	process in the specified dates of admission, their admission will be
	cancelled automatically.
9.	The verification of original certificates will be conducted at the time of
	admission in the respective college and in case of any discrepancy, the
	Provisional allotment will be cancelled and action will be initiated. It the
	candidate slides to other college (i.e., affiliated colleges of Dr. YSR UHS)
	during subsequent phases of counselling, the original certificates will be
	sent to the college concerned by the college where the candidate has
	slide.

10.	Students who have already paid the University fee in Phase-I need not pay
	again if seat is allotted in Phase-II/Final counselling, but should download
	the allotted order if there is a change in Phase-II/Final counselling.
	Vacancies available for this Phase - II of counselling.
11.	After the cutoff date for reporting i.e., by 01.00 PM on 08.02-2023, no
	candidate should be admitted and their Provisional admission is deemed to
	be cancelled without any further intimation.
12.	Principals have to upload the Report/Not Reported data in the Website <u>https://ugaiqprincipal.ntruhsadmissions.com by</u> 02.00 PM on 08.02-2023.
