Admissions into BDS Course under Competent Authority Quota Seats for the academic year 2022-23

NOTIFICATION

In continuation to the notification dt.03.12.2022, the following instructions are hereby issued with regard to Phase - I Admissions made into BDS Course under Competent Authority Quota Seats for the academic year 2022-23.

1. To Retain/Continue in the Phase-I Reported College/Seat

a. Phase-I reported/joined candidates, who are willing to retain/continue in the existing seat shall submit their self-declaration as per the following schedule

b. This is not applicable to the candidates who have been allotted a college/seat as per their 1st option (of the prioritised options) and reported/joined at that college.

- c. The candidates who have submitted self-declaration to retain/continue in the reported/joined seat of Phase-I will not be considered for upgradation in next phase of counselling (except for default sliding within the same college as per the one-time options already exercised), but will be retained in the existing seat. No further correspondence will be entertained in this regard.
- d. Phase-I reported/joined candidates who have not submitted self-declaration to retain in the reported/joined seat will be considered for Phase-II of counselling for upgradation/sliding as per the one-time options already exercised.
- e. As per the orders dated.22.07.2022 of the Hon'ble Supreme Court of India in Contempt Petition (C) No.289 of 2022 and as per the Notice 12021/01/2022-MEC, dt.12-07-2022 of DGHS, Ministry of Health & Family Welfare, Govt. of India, New Delhi, the joined candidates up to round 2 of AIQ or State Quota shall not be eligible to participate in the further rounds for All India Quota or for State Quota from the academic year 2022-23 onwards.

2. <u>Procedure for submitting self-declaration to retain at the Phase-I reported/joined seat:</u>

- a. Phase-I reported/joined candidates will receive messages from Dr. YSR UHS, Vja regarding submission of self-declaration to retain/continue at the Phase-I reported/joined seat of BDS course for the academic year 2022-23. Candidates who are willing for upgradation (as per the one-time options already exercised) can ignore the message.
- b. Interested candidates shall login into https://ugcq.ntruhsadmissions.com/
- c. After login, candidate shall enter the OTP received to the registered mobile number or email. If OTP is not received for long time, please click on "RESEND" for getting OTP again.

- d. After that the candidate can see the details of Reported/Joined college. If the candidate willing to retain/continue in the reported/joined college, he / she shall click the check box and click "Submit with OTP".
- e. Enter OTP received to the Mobile/Email and shall click on "Verify & Submit" Button.
- f. After successful submission with OTP, candidates can take print out of the same by clicking on "PRINT" button for future reference
- g. Once the candidate completes the said procedure, it will be confirmed that the candidate has accepted and willing to retain and continue in the Phase-I reported seat. No request for change, if any will be entertained under any circumstances.
- 3. Decision of the Competent Authority is final.
