NOTIFICATION FOR EXERCISING WEB OPTIONS FOR STRAY VACANCY COUNSELLING FOR
ADMISSION INTO BDS COURSE, 2023-24 UNDER MANAGEMENT QUOTA SEATS

In continuation to this Office notifications dated.13.10.2023 & 20.10.2023, Dr. YSRUHS, Vijayawada hereby notifies the schedule for exercising **Web Options for Stray vacancy counselling for admissions into BDS course** for the academic year 2023-24 under Management Quota:

All the candidates whose names are present in the eligible candidates for stray vacancy displayed on 26.10.2023 in the University Website and who are not holding MBBS / BDS seat in earlier Phases of counselling (both Competent Authority Quota and Management Quota) / All India Quota / KNR UHS, Telangana are only eligible to exercise web options on the above schedule dates as per the Seat Matrix displayed in the website:

University Fee:

The selected candidates have to download the allotment order by paying the following University fee through Payment Gateway by using online payment method. (Debit Card/Credit Card/Internet Banking/UPI) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college.

BDS Course:-

Tuition Fee:

As per G.O.Ms.No.111 HM & FW, (C1) Department, Dt.24-07-2023, the following is the tuition fee in respect of the Category-B & C seats in Private Un-aided Minority and Non-Minority Dental Colleges in Andhra Pradesh per annum for 4 years.

Instructions to Candidates: -

1. **Who are eligible for exercising web options for stray vacancy round:**
 - a. Candidate should not hold any seat under Dr. YSR UHS both CQ and MQ / All India Quota / KNR University of Health Sciences, Telangana.
 - b. A list of eligible candidates for stray vacancy is placed in the University website.
 2. **Who are NOT eligible for stray vacancy round:**
 - a. Candidate joined / holding any seat under Dr. YSR UHS / All India Quota / KNR University of Health Sciences, Telangana / Other States are not eligible for stray vacancy round.
 - b. If it is found that an ineligible candidate has opted, candidature of such candidates will not be considered for allotments. Application fee paid if any, will not be refunded.
 3. Candidates allotted seats in this stray vacancy round should compulsorily join in the allotted seat.
 4. Candidates who are willing join BDS Course under Stray Vacancy counselling have to exercise web options carefully as per their priorities category wise / college wise. The allotments will be as per the prioritized options exercised by the candidates.
 5. **The options exercised for stray vacancy round under Management Quota will be considered as One-time options for the purpose of stray vacancy round and will be considered for further rounds, if any.**
 6. In respect of Category-B2 seats, preference will be given to local candidates of Andhra Pradesh and if eligible candidates from Andhra Pradesh are not available, the same will be allotted to Category-B1 candidates based on Merit, Options and subject to availability of seats.
 7. The details of number of seats available under Management Quota (Category B1, B2 & Category C) in Private Unaided Non-Minority Dental Colleges and Minority Dental College in Annexure-I.
 8. Candidates will receive the message regarding allotment of seat, if seat is allotted.
 9. Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.
 10. Selected candidates have to report to the Principal of the allotted college within the stipulated date and time for joining as specified on the allotment letter with all original certificates and relevant bonds, if any, and pay the tuition fee and college fee to complete the process of admission. If the candidate fails to report before the reporting date and time, the admission will be cancelled automatically.
 11. The University fee once paid shall not be refunded under any circumstances.
 12. As per G.O.Ms.No.72, HM&FW (C1) Dept., dt.15-07-2019, if any candidate wants to withdraw from the course after the closure of admissions, in the middle of the course such candidate has to submit his/her request through the Principal of the college concerned along with course discontinuation fee of Rs.1,00,000/- for BDS plus GST as applicable to the University by way of demand draft drawn in favour of the Registrar, Dr. YSR University of Health Sciences, payable at Vijayawada.
- Note:** The requests received directly from the candidates for withdrawal from BDS course will not be entertained under any circumstances. Any request shall be routed through Principal concerned only as per the G.O.Ms.No.72, HM & FW (C1) Dept., dated.15-07-2019.
13. Decision of Competent Authority is final.
 14. **Dr. YSR University of Health Sciences does not entertain or support seat blocking / cancellation of BDS seats.**
 15. **In case any student is found involved in seat blocking, legal action will be initiated against such candidate as per rules.**

16. No candidate will be permitted to cancel the BDS seat under Management Quota after stray vacancy round counseling.
17. The Candidates are hereby informed that if it is found at any stage of admission or later that they have secured admission in medical / dental colleges of other states, joined the course and they are involved in blocking the seats under management quota in Dr. YSR UHS, the university will initiate legal action and also inform the same to National Medical Commission / Dental Council of India for further course of action.
