INSTRUCTIONS

1. Candidates whose names are already present in the CQ Merit list are also eligible for Stray vacancy round provided they satisfy the eligibility conditions of Stray vacancy round under this Notification and hence such candidates need not apply in response to this Notification.
2. Candidates who have been allotted any PG (Dental) seat in any Phase including Mop Up rounds of CQ and MQ counsellings of Dr.YSR UHS, Vijayawada are not eligible to participate in Stray vacancy round.
3. Candidate joined / holding any seat of PG (Dental) Course under Dr. YSR UHS / All India Quota / KNR University of Health Sciences, Telangana / Other States are not eligible for stray vacancy round. Such candidates shall not apply for this notification.
4. Candidates who have not exercised/participated for web options in any phase of CQ seats are not eligible for participating in Stray round.
5. Candidates must join the seat allotted in this stray round if seat is allotted, failing which candidates shall be debarred for one academic year i.e., 2024-25 for admissions into Dental Colleges in the State of Andhra Pradesh.

If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
5. **Registration along with uploading of Scanned Original certificates and exercising of web options will be permitted only once irrespective of the Number of counsellings.** No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
6. The Candidates are hereby informed that if they have secured admission in Dental colleges of other States, joined the course and if they are involved in blocking of the seats the University will initiate legal action and same will be informed to the DCI, New Delhi.
7. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
