- 1. Candidates whose names are already present in the MQ Merit list of Dr.YSR UHS are also eligible for Stray vacancy round provided they satisfy the eligibility conditions of Stray vacancy round under this Notification and hence such candidates need not apply in response to this Notification.
- 2. Candidates who have been allotted any PG (Dental) seat in any Phase including Mop Up rounds of CQ and MQ counsellings of Dr.YSR UHS, Vijayawada are not eligible to participate in Stray vacancy round.
- 3. Candidate joined / holding any seat of PG (Dental) Course under Dr. YSR UHS / All India Quota / KNR UHS, Telangana / Other States are not eligible for stray vacancy round.
- 4. Candidates who have not exercised/participated for web options in any phase of MQ seats of Dr.YSR UHS are not eligible for stray vacancy round
- 5. Candidates must join the seat allotted in this stray round if seat is allotted, failing which candidates shall be debarred for one academic year i.e., 2024-25 for admissions into Dental Colleges in the State of Andhra Pradesh.

No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
- 6. The Candidates are hereby informed that if they have secured admission in Dental colleges of other States, joined the course and if they are involved in blocking of the seats the University will initiate legal action and same will be informed to the DCI, New Delhi.
