In continuation of earlier notifications dated 30-10-2023, 10.11.2023 & 30.11.2023 the University hereby notify the Phase-II/Final web-based counselling for admission into PG AYUSH (i.e, MD (Homoeo) & MD/MS (Ayurveda) courses for the academic year 2023-24 in the colleges affiliated to Dr. YSR University of Health Sciences, Vijayawada in the state of Andhra Pradesh.

All the eligible candidates who are present in the Merit lists notified in the website on **30.11.2023** are only eligible to exercise their options as per the seat matrix displayed on the **website** https://drysr.uhsap.in

The seat allocation will be done as per the Procedure given in G.O.Ms.No.603, HM & FW (R2) Dept., dt.23.12.2004 as amended in G.O.Ms.No.13, HM & FW(F2) Dept., dt.05.02.2021.

UNIVERSITY FEE: Candidates who are allotted with a seat, have to pay Rs. 10,100/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking).

Instructions to Candidates:

- The candidates who secured their AIQ-PG seats through Round-I, II, III & Stray Vacancy Round of AACCC – PG Counselling 2023 are not eligible to participate in this counselling as per Ref.AA-12013/3/2023-EP-I, Dt.05.12.2023. If it is found that the in-eligible candidate participated in this counselling, candidature of such candidate will be cancelled and will not be permitted in further counsellings
- 2) If a candidate is allotted a seat in MD(Homoeo) & MD/MS(Ayurveda) courses as per his/her options and does not join the course under the Competent Authority Quota Phase-II/Final counselling he/she will not be eligible for Mop-up Round of counseling to prevent seat blocking.
- 3) Vacancy position is displayed on University website for the information of the students to exercise their options.
- 4) Phase-I seats vacated because of sliding to other colleges during the course of Phase-II/Final counselling will be added and allotted simultaneously to the next candidates as per the Merit and Rules

5) The following are the vacancies available for Competent Authority Quota Phase-II/Final Counselling

- 6) Fresh options will be obtained from all the eligible candidates.
- 7) Candidate can give options on the web either from home or any other place having internet facility
 - a) One Time Password will be sent to the registered mobile at the time of registration and also at the time of saving Web options.
 - b) The password consists of SIX letter code with English capitals A to Z.
- 8) candidate can exercise any number of options. The students have to opt clearly for the course in which they are desirous to join.
- 9) Conversions will be conducted in this Phase-II/Final Phase counseling for filling up of the unfilled vacancies if any as per the rules.
- 10)Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options.
- 11)Candidates will receive the allotment order after allotment of seat, if seat is allotted. The candidates are also instructed to visit the **websites:**

- 12)Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
- 13)Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
- 14) The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr.YSR UHS) during subsequent Phases of counsellings, the original certificates will be sent to the college concerned after the closure of admissions.
- 15)Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II/Final, but should download the allotted order if there is a change in Phase-II/Final



- 16)The University fee once paid shall not be refunded under any circumstances.
- 17)As per G.O. Ms No.13, HM & FW (F2) Dept., dt. 05.02.2021, If any candidate wish to discontinue their course, after closure of the admission (or) during the course of period should pay of Rs. 50000/-+9000/-@18% GST (Rupees Fifty Nine thousand only) in the form of DD drawn in favour of the Registrar, Dr.YSR University of Health Sciences, A.P., Vijayawada.
