Notification for exercising web options for admissions into Post Graduate Dental Degree/Diploma Courses against Stray Vacancy Round-2 to be conducted by Dr. YSR UHS for the academic year 2023-2024 in the State of A.P. under Competent Authority Quota Post Graduate Dental Degree / Diploma courses, in Government and Private Un-aided Non-minority Dental Colleges affiliated to Dr. YSR UHS (subject to availability of seats at the end of stray vacancy round).

INSTRUCTIONS

- 1. Eligible Non-Service candidates whose names are in the Final Merit Position notified in the University Website are only eligible to exercise web options as per the above dates.
- 2. All the unfilled seats for Stray vacancies are converted as "Unreserved Open General seats".
- 3. The following candidates are not eligible to exercise options under this Notification:
- a) Candidates who have been allotted any PG (Dental) seat in any Phase including Mop Up rounds of CQ and MQ counsellings of Dr.YSR UHS, Vijayawada are not eligible to participate in Stray vacancy round.
- b) Candidate joined / holding any seat of PG (Dental) Course under Dr. YSR UHS / All India Quota / KNR University of Health Sciences, Telangana / Other States are not eligible for stray vacancy round..
- c) Candidates who have not exercised/participated for web options in any phase of CQ seats are not eligible for participating in Stray round.
- d) Allotted candidates of Stray Vacancy Rounds of both CQ & MQ conducted on 24-10-2023 are not eligible for this stray vacancy round.
- 4. **IMPORTANT NOTE**: Candidates if allotted any seat in this Round should compulsorily join the course failing which candidates shall be debarred for one academic year i.e., 2024-25 for admissions into Dental Colleges in the State of Andhra Pradesh. As such they are advised to give options to the courses for which they are really interested to join so as to give chance to next meritorious candidates.
- 5. Candidate can download the provisional allotment order on payment of University fee of Rs.23,600/- through payment gateway and report to the Principal of the allotted College on or before the date specified in the allotment order.
- 6. The allotted candidates shall report at the allotted college immediately in view of NMC, New Delhi schedule. Hence, candidates are advised to keep in touch with University website for information on Stray allotments.

- 7. The University fee once paid shall not be refunded under any circumstances.
- 8. **TUITION FEE FOR PG DENTAL**: The following is the **Tuition fee structure** for the academic year 2023-24 to be payable for the Competent Authority Quota seats in Private Un-aided Dental Colleges as per G.O.Ms.No.123, HM & FW (C1) Department, dated 10-08-2023 of Government of Andhra Pradesh subject to the outcome of the W.P.Nos.32975, 33162 & 35090 of 2022.
