#### SCHEDULE

All the candidates whose names are listed in the Consolidated Final Merit Position, dt.10.10.2023 and Addendums/Corrigendums notified in the University Website are only eligible to exercise web options on the above scheduled dates.

#### **UNIVERSITY FEE:**

- 1. Candidates to whom seat is allotted have to pay Rs.49,600/- for downloading allotment letter. The payment is to be paid through payment Gateway by using Online payment method. (Debit Card/ Credit Card/Internet Banking).
- 2. Candidates who have already paid the University fee of Rs.49,600/as per Notifications, dt.24-08-2023/01-09-2023/07-09-2023 are not required to pay again to download the Allotment letter.

TUITION FEE FOR PG MEDICAL: The following is the Tuition fee structure for the academic year 2023-24 to be payable in Private Un-aided Non-Minority and Minority Medical Colleges is as per G.O.Ms.No.123, HM & FW (C1) Department, dated 10-08-2023 of Government of Andhra Pradesh subject to the outcome of the W.P.Nos.32975, 33162 & 35090 of 2022.

#### Distribution of seats is as detailed below:

- In case of Private Non-Minority Medical Colleges as per G.O.Ms.No.102, HM&FW (C1) Dept., dated 15-07-2023:
  - a) 15% of Subcategory-1 seats only are open to the candidates from all over the Country and shown as "**S1A**" in the Seat Matrix
  - b) For the remaining 85% of Subcategory-1 seats shown as "**S1B**" in the seat matrix, only Local Candidates of Andhra Pradesh i.e., AU/SVU local candidates are only eligible.
- As per G.O.Ms.No.57, HM&FW (C1) Dept., dated 28-04-2023 (Non-Minority Colleges) and G.O.Ms.No.74, HM&FW (C1) Dept., dated 06-06-2023 (Minority Colleges):
- a) Management Quota-Subcategory- 1(S1): 25% of the sanctioned intake of seats, course wise, in each institution
- b) Management Quota-Subcategory-2(S2): 15% seats out of total intake capacity, course wise, in each institution shall be filled by foreign students/ NRI/NRI sponsored candidates on the basis of inter-se-merit among the applicants qualified in NEET PG-2023..
- c) Management Quota-Subcategory-3(S3): 10% seats out of total intake capacity, course wise, in each Institution shall be Institutional preference/In- service management quota seats filled on the basis of inter-se-merit among the applicants qualified in NEET PG-2023.

### **Instructions to Candidates:**

1	Not Reported list of MQ-PG (Medical) seats was placed in the University website, dt.09-10-2023		
2	Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are really interested. If they are not interested to join any speciality or college then they should not exercise options for the same.		
3	1. Candidates opting for PG(Medical) Degree/Diploma courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of subjects and colleges if the candidate is interested to join as per eligibility.		
	2. Candidates are advised to exercise web options for PG seats in all courses and colleges in which they are interested to join irrespective of available seats as vacancies will arise during counseling process due to sliding of candidates from allotted seats in the Revised Phase-I counseling, dt.09-09-2023 to other seats as per their web options in this Phase-II counseling. If candidates are not interested to join in any subject or college they should not exercise web options for the same.		
	3. If a PG seat is allotted in this Phase-II counseling as per web options exercised by the candidate, the seat allotted in Revised Phase-I counseling, dt.09-09-2023 will be automatically cancelled and allotted to the other candidate. Therefore the candidates are informed to exercise web options carefully.		
4	Candidate can exercise web options from any place having internet facility. One Time Password will be sent to the registered mobile number at the time of saving Web options.		
	I) Priority of Selected Options can be altered		
	II) Web options opted must be saved by the candidate.		
	III) Web options once submitted can not be Edited.		
	IV) Web options saved but not submitted until the cut off date and time will be Auto submitted.		
5	The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated.		
6	1. The selected candidates shall produce all the Original certificates, pay the Tuition fee, necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.		
	2. Candidates who were allotted a seat in Revised Phase-I counselling, dt.09-09-2023 in any college of AP State, joined and slided to another college in AP in this Phase-II counseling, should submit the tuition fee receipt, Custodian/acknowledgement of Original certificates issued by the earlier college for admission at the newly allotted college. The first college where the candidate initially joined in Revised Phase-I, dt.09-09-2023 will transfer the tuition fee, Original certificates etc., to allotted college in this Phase-II.		

7	The following candidates are eligible:		
	a) Those candidates who have been allotted a seat and reported/joined in Revised Phase-I, dt.09-09-2023.		
	b) Those candidates who have not been allotted any seat in the Revised Phase-I counselling, dt.09-09-2023.		
	c) Those candidates who have been allotted a seat in the Revised Phase-I, dt.09-09-2023 but not reported/not joined at the allotted colleges. However, if a candidate has not joined/reported in the allotted seat of Revised Phase-I, dt.09-09-2023 then that particular seat shall not be available for that candidate to exercise web options in Phase-II counselling.		
	The following candidates are <b>NOT ELIGIBLE</b> :		
	1. Candidates joined and continuing in Round-1 and Round-2 of All India Quota (AIQ)		
	2. Allotted Candidates of Round-3/Stray round of All India Quota (AIQ)/Stray round of KNR UHS, TS.		
	<ul><li>3. Candidates holding any seat of AIQ</li><li>4. Candidates joined and continuing in the PG (Medical) seat of Competent Authority Quota in the Colleges of A.P State.</li></ul>		
	5. Candidates for whom seat is allotted in CQ Phase-II Non-service of Dr.YSR UHS		
	held on 18-10-2023 desires to Report/Join at the allotted colleges shall not		
	exercise web options for this MQ Phase-II, eventhough, if exercised the web options		
	shall be removed.		
	6. Candidates joined and continuing in the colleges of Telangana State		
	Hence, the above said candidates should not exercise web options.		
	Mop Up Round:		
	<ul> <li>a) Candidates who have exercised/participated for web options in Revised Phase-I, dt.09-09-2023 &amp; Phase-II of MQ seats but not allotted any seat are eligible for Mop Up round.</li> </ul>		
	b) Candidates who have not exercised/participated for web options in any phase of MQ seats are not eligible for participating in Mop Up round.		
	c) Candidates who have been allotted any seat in any Phase of counselling of MQ seats are not eligible to participate in the MoP Up Round.		
	d) Candidates who have already joined/continuing any seat in any Medical college are not eligible to participate in MoP Up Round.		
8	As per G.O.Ms.No.67, dt.21-04-2017 in the final phase of final counselling:		
	A candidate who exercised web options and joined in an allotted seat shall not be permitted to withdraw from the seat. In case any candidate withdraws from the allotted seat, the candidate shall be debarred for a period of three years for admission into Post Graduate Medical Degree/Diploma courses at the colleges in the State of Andhra		
	Pradesh besides payment of Rs. 3,54,000/- (including 18% GST).
