- a. Candidates who have already submitted Online applications for this academic year 2023-24 and whose names are present in the Final Merit list displayed on 09.11.2023 under All India Quota (AIQ) Seats in Private un-aided Non-Minority BAMS & BHM Colleges need not apply again and they will be considered for remaining rounds of counselling as per Rules.
- b. Fresh registrations will be considered for remaining rounds of counselling for the available vacancies only.
- c. Last date of admissions 30.11.2023.
- d. The other conditions notified in the earlier notifications/Prospectus, dt.26.10.2023 will remain same.
