NOTIFICATION FOR EXERCISING WEB OPTIONS FOR PHASE-II/FINAL COUNSELING FOR INSERVICE CANDIDATES FOR ADMISSIONS INTO THE COMPETENT AUTHORITY QUOTA SEATS OF POST-GRADUATE DENTAL DEGREE/DIPLOMA COURSES AVAILABLE IN THE GOVERNMENT AND PRIVATE NON-MINORITY DENTAL COLLEGES AFFILIATED TO Dr.YSR UHS FOR THE ACADEMIC YEAR 2023-24.

In continuation to this Office Notifications, dt.21-07-2023 & dt.22-08-2023, Dr.YSR UHS, Vijayawada hereby notifies the schedule for exercising Web Options for Phase-II/Final of counselling for **In-service candidates** for admissions into Competent Authority Quota (CQ) PG Dental Degree/Diploma courses available in the Government and Private Non-Minority Dental Colleges under Dr. YSR UHS for the academic year 2023-2024 for the unfilled seats after Phase-I counselling:

UNIVERSITY FEE: Candidates to whom seat is allotted have to pay Rs.23,600/for downloading allotment letter. The payment is to be paid
through payment Gateway <a href="https://mdscq.ysruhs.com/">https://mdscq.ysruhs.com/</a> by using
Online payment method. (Debit Card/Credit Card/Internet
Banking). Candidates already paid in Phase-I need not to pay
again.

### Instructions to Candidates:

- 1 Area wise Seat Matrix was displayed in the University Website on 22-08-2023 for information of the candidates to exercise their Web options.
- Candidates are advised to go through the Prospectus (placed in the University website on 21-07-2023) and the Government Orders on Rules of PG admissions available before exercising web options. Candidates are also advised to go through the details about "MRC" concept which is exemplified below:

#### Example:

- a) In a particular college MDS(Conservative Dentistry) seat is under "Open Category" in the seat matrix and a SC candidate is allotted that Open Category MD(Conservative Dentistry) seat in Open Round Counselling of Phase-I as per his/her web options and NEET -MDS Rank merit order of the candidate. Now this candidate is shown as Meritorious Reserved Candidate (MRC).
- b) The same SC candidate has slided to MD (Prostho) SC category seat in the same college or another college during the Category Round of Phase-I Counselling **conducted on the same day**, then that MD(Conservative Dentistry) seat vacated by this MRC candidate shall be filled with the SC candidates only by merit amongst them.
- c) This type of MRC concept is to be followed for all BC/SC/ST categories in order to maintain 50 : 50 ratio of Open : Category Reservation

- Candidates opting for Dental Degree/Diploma courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of subjects and colleges if the candidate is interested to join as per eligibility.

Candidates while giving options should note that the seats vacated by the candidates selected in Phase-I counselling and slided to other college/course during this 2<sup>nd</sup> & Final Phase of counseling process will be added & allotted simultaneously during this Phase of counseling itself.

The candidates are therefore advised to exercise options for all the seats in all the colleges as per their priority irrespective of vacancies shown in seat matrix. <u>Candidates are advised to give options to the courses for which they are really interested to join, so as to give chance to next meritorious candidates</u>

- 4 Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are really interested. If they are not interested to join any subject or college then they should not exercise options for the same.
- Candidate can exercise web options from any place having internet facility One Time Password will be sent to the registered mobile number at the time of saving Web options.
  - I) The Priority of Selected Options can be changed.
  - II) Web options opted must be saved by the candidate.
  - III) Web options once submitted can not be Edited.
  - IV) Web options saved but not submitted until the cut off date and time will be Auto submitted.
- Candidates who were allotted a seat in Phase-I counselling in any college of AP State, joined and slided to another college in AP in this 2nd & Final Phase counselling, should submit the tuition fee receipt along with relief letter issued by the earlier college, for admission at the newly allotted college. The first college where the candidate initially joined in Phase-I will transfer the tuition fee, Original certificates etc., to subsequently allotted college in AP State.
- The selected candidates shall produce all the Original certificates, pay the Tuition fee, necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.

8	3	The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr.YSR UHS) during subsequent Phases of counselling the tuition fee already paid will be transferred to the slided college by the concerned college where the amount is held.
Ç	9	As per G.O.Ms.No.67, dt.21-04-2017 in the final phase of final counselling: A candidate who exercised web options and joined in an allotted seat shall not be permitted to withdraw from the seat. In case any candidate withdraws from the allotted seat, the candidate shall be debarred for a period of three years for admission into Post Graduate Dental Degree/Diploma courses at the colleges in the State of Andhra Pradesh besides payment of Rs. 3,54,000/- (including 18% GST).
1	10	The University fee and other fee once paid shall not be refunded under any circumstances.
