REVISED PHASE-I NOTIFICATION FOR WEB OPTIONS- PG (MEDICAL)
ADMISSIONS 2023-24
MANAGEMENT QUOTA (S1/S2/S3) SEATS

A Notice vide No.M-19011/33/2023-MARB/050061-65, dt.05-09-2023 of NMC, New Delhi was issued in the NMC, New Delhi website duly stating that Fake/Forged Letter of Permission to GSL Medical college, Rajahmundry for increase of seats in MD (RD) from 10 to 24 for the academic year 2023-24 was issued.

In response this Office Letter No.3108/A2/NMC/2023, dt.06-09-2023, the NMC, New Delhi has clarified through e-mail, dt.07-09-2023 that Letter of Permissions (LoPs) were not issued to GSL Medical College, Rajahmundry in the following specialities for enhancement of seats for this academic year 2023-24:

1. MD (Radio Diagnosis)
2. MD (Emergency Medicine)

Therefore, the Revised Phase-I admissions into Management Quota for PG(Medical) courses for the academic year 2023-24 released on 04-09-2023 are hereby cancelled.

HENCE NOTIFICATION FOR EXERCISING FRESH WEB OPTIONS FOR REVISED PHASE-I COUNSELLING OF MANAGEMENT QUOTA SEATS (S1(A/B), S2 & S3) FOR ADMISSIONS INTO THE POST GRADUATE MEDICAL DEGREE/DIPLOMA COURSES INTO NON-MINORITY AND MINORITY MEDICAL COLLEGES FOR THE ACADEMIC YEAR 2023-2024 IS HEREBY ISSUED.

In continuation to this Office Notifications, dt.24-08-2023, 30-08-2023, 31-08-2023 & 01-09-2023, Dr. YSR UHS, Vijayawada hereby notifies the schedule for exercising fresh Web Options for Revised Phase-I counselling for admissions into Management Quota seats of PG Medical Degree/Diploma courses in Private Un-aided Non-minority and Minority Medical Colleges (FIMS, Kadapa & NIMRA, Ibrahimpatnam) for the academic year 2023-24:

Note: If any candidate does not exercise web options for this revised Phase-I, dt.07-09-2023, then the web options already saved/submitted by the candidate in Revised Phase-I in response to this Office Notification, dt.01-09-2023 for MQ seats (Except MD(RD) and MD (EM) specialities in GSL Medical College, Rajahmundry) will be considered for this Revised Phase-I counselling.

All the candidates whose names are listed in the Final Merit Position, dt.24.08.2023 and Addendums/Corrigendums notified in the University Website are only eligible to exercise web options on the above schedule dates. UNIVERSITY FEE:

1. Candidates to whom seat is allotted have to pay Rs.49,600/- for downloading allotment letter. The payment is to be paid through payment Gateway by using Online payment method. (Debit Card/ Credit Card/Internet Banking).
2. Candidates who have already paid the University fee of Rs.49,600/- as per Notification, dt.24-08-2023 & 01-09-2023 are not required to pay again to download the Allotment letter.

TUITION FEE FOR PG MEDICAL: The following is the **Tuition fee structure** for the academic year 2023-24 to be payable in Private Un-aided Non-Minority and Minority Medical Colleges is as per G.O.Ms.No.123, HM & FW (C1) Department, dated 10-08-2023 of Government of Andhra Pradesh subject to the outcome of the W.P.Nos.32975, 33162 & 35090 of 2022.

Distribution of seats is as detailed below:

- 1) In case of Private Non-Minority Medical Colleges as per G.O.Ms.No.102, HM&FW (C1) Dept., dated 15-07-2023:
 - a) 15% of Subcategory-1 seats only are open to the candidates from all over the Country and shown as "**S1A**" in the Seat Matrix
 - b) For the remaining 85% of Subcategory-1 seats shown as "**S1B**" in the seat matrix, only Local Candidates of Andhra Pradesh i.e., AU/SVU local candidates are only eligible.
- 2) As per G.O.Ms.No.57, HM&FW (C1) Dept., dated 28-04-2023 (Non-Minority Colleges) and G.O.Ms.No.74, HM&FW (C1) Dept., dated 06-06-2023 (Minority Colleges):
 - a) Management Quota-Subcategory- 1(S1): 25% of the sanctioned intake of seats, course wise, in each institution.
 - b) Management Quota-Subcategory-2(S2): 15% seats out of total intake capacity, course wise, in each institution shall be filled by foreign students/ NRI/NRI sponsored candidates on the basis of inter-se-merit among the applicants qualified in NEET PG-2023.
 - c) Management Quota-Subcategory-3(S3): 10% seats out of total intake capacity, course wise, in each Institution shall be Institutional preference/In- service management quota seats filled on the basis of inter-se-merit among the applicants qualified in NEET PG-2023.

Instructions to Candidates:

1	The Revised Seat Matrix is already displayed in the University Website on 07-09-2023 for information of the students to exercise their Web options.
2	Candidates are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of specialities and colleges if the candidate is really interested to join that particular speciality in a particular college as per eligibility.
3	Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are really interested. If they are not interested to join any speciality or college then they should not exercise options for the same.
4	Candidate can exercise web options from any place having internet facility. One Time Password will be sent to the registered mobile number at the time of saving Web options. I) Priority of Selected Options can be altered II) Web options opted must be saved by the candidate. III) Web options once submitted can not be Edited. IV) Web options saved but not submitted until the cut off date and time will be Auto submitted.
5	The selected candidates shall produce all the Original certificates, pay the Tuition fee, necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the criteria as per regulations to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
6	The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr. YSR UHS) during subsequent Phases of counselling the tuition fee will be sent to the slided college by the concerned college where the amount is held.
7	Eligibility for Exercising web options in Phase-II Counselling The following candidates are eligible: a) Those candidates who have been allotted a seat and reported/joined. b) Those candidates who have not been allotted any seat in this Revised Phase-I counselling. c) Those candidates who have been allotted a seat in this Revised Phase-I but not reported/not joined at the allotted colleges. However if a candidate has not joined/reported in the allotted seat of Revised Phase-I then that particular seat shall not be available for that candidate to exercise web options in Phase-II counselling. <u>Mop Up Round:</u> a) Candidates who have exercised/participated for web options in Revised Phase-I, dt.07-09-2023 & Phase-II of MQ seats but not allotted any seat are eligible for Mop Up round. b) Candidates who have not exercised/participated for web options in any phase of MQ seats are not eligible for participating in Mop Up round. c) Candidates who have been allotted any seat in any Phase of counselling of MQ seats are not eligible to participate in the MoP Up Round.
8	As per the National Medical Commission, New Delhi, Letter No.N-P018(20)/5/2023-PGMEB-NMC/044351, dt.24-07-2023 the Stray vacancy round for the seats if any available at the end of Mop Up round(s) in all Government and Private Medical Colleges including Minority Medical Colleges affiliated to Dr.YSR UHS shall be conducted by Dr.YSR UHS in online mode from the academic year 2023-24.
