Prospectus for admissions into "Post Graduate Dental Degree / Diploma Courses under Competent Authority Quota for the academic year 2023-24"

REGULATIONS:

The following are the Regulations for admission into the Competent Authority Quota (CQ)/State quota (SQ) seats of all Post Graduate Dental Degree/Diploma Courses in all the Dental Colleges affiliated to Dr. YSR UHS for the academic year 2023-24.

1. NUMBER OF SEATS UNDER COMPETENT AUTHORITY QUOTA:

- a. Government Dental Colleges: 50% of the total available seats are in State quota under Competent Authority. 50% of seats are surrendered to AIQ which are filled by MCC, New Delhi.
- b. Private Un-Aided Non- Minority Dental Colleges: 50% of the total available seats are in Competent Authority Quota. Remaining 50% are under Management Quota(MQ).
- c. The details of the seats available under Competent Authority quota for the year 2023-24 will be displayed in the University website before the start of web counseling.

2. ELIGIBILITY: THE CANDIDATES WHO FULFILLED THE FOLLOWING CRITERIA ARE ELIGIBLE:

- 2.1 The applicant for admission to the PG Dental Degree/Diploma courses must have a B.D.S. Degree (Bachelor of Dental Surgery) from a recognized Dental college/University.
- 2.2 The candidates should have secured the following cutoff scores and above in NEET MDS-2023

| Name of category | Eligibility Criteria as per NBE, New Delhi | Cut-off score |

- 2.3 Candidates should have completed internship by **30-06-2023**.
- 2.4 The candidate shall produce certificate of registration with Dental Council of India / Any State Dental Council.

3. Tuition Fee Structure:

The Tuition fee in Private un-aided Minority and Non-Minority Medical and Dental colleges for PG Medical/Dental course will be as per the G.O to be released by the Govt. of A.P.

4. ALLOTMENT OF SEATS:

- 4.1 a. The Courses at Government Dental College & Hospital, Vijayawada are State-wide.
b. The Courses at Government Dental College & Hospital, RIMS, Kadapa are Non State-wide.

- 4.2 The Courses available at Private un-aided Non Minority Dental Colleges are Non - Statewide. Selection procedure for Competent Authority Quota seats shall be regulated as per the procedure envisaged in Annexure III of G.O.P.No.646, Education Dept., dated. 10.07.1979.

5. RESERVATION IN FAVOUR OF THE LOCAL CANDIDATES:

Admission to 85% of the seats shall be reserved in favour of the local candidates in relation to the local area as provided in A.P. Educational Institutions (Regulation of Admission) order, 1974 for Non-State wide courses as given in Annexure-III of GO (P) No. 646, Edu. (W1) Department, dt.10-7-1979.

5.1 LOCAL AREA :

- 5.1.1 The part of the State comprising the Districts of Srikakulam, Vizianagaram, Visakhapatnam, East Godavari, West Godavari, Krishna, Guntur and Prakasam shall be regarded as the local area for the purposes of admission to the Andhra University, (Nagarjuna University) and to any other educational institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.
- 5.1.2 The part of the State comprising the Districts of Telangana State shall be regarded as local area for the purposes of admission to the Osmania University, (the Kakatiya University) and to any other educational institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.
- 5.1.3 The part of the State comprising the Districts of Anantapur, Kadapa, Kurnool, Chittoor and Nellore shall be regarded as local area for the purposes of admission to Sri Venkateshwara University and to any other educational institution (other than a State-wide University or State-wide Educational Institution) which is subject to the control of the State Government and is situated in that part.

5.2 LOCAL CANDIDATES:

5.2.1 A candidate for admission shall be regarded as local candidate in relation to a local area.

- i) If he/she studied in an Educational Institution or Educational Institutions in such local area for a period of not less than 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared in relevant qualifying examination.

Or

- ii) Where during the whole or any part of the 4 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in Educational Institutions, if he/she had resided in that local area for a period of not less than 4 years immediately preceding the date of commencement of the relevant qualifying examination, in which he/she appeared or as the case may be first appeared.

5.2.2 For candidates who have completed BDS Degree from State Wide College:
A candidate for admission to any course of study who is not regarded as a local candidate under sub-regulation (5.2.1) in relation to any local area shall

- i) If he/she has studied in educational institutions in the State for a period of not less than 7 consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for the relevant qualifying examination be regarded as local candidate in relation to:
- a) Such local area where he/she has studied for the maximum period out of the said period of 7 years.
- b) Where the period of his/her study in two or more local areas are equal, such local area where he/she has last studied in such equal periods.

or

- ii) If during the whole or any part of the seven consecutive academic years ending with academic year in which he/she appeared or as the case may be first appeared for relevant qualifying examination, he/she has not studied in the educational institution in any local area, but he/she has resided in the State during the whole of the said period of 7 years be regarded as a local candidate in relation to
- a) Such local area where he/she has resided for the maximum period out of the said period of 7 years.

or

- b) Where the period of his/her residence in two or more local areas are equal, such local area where he/she has resided last in such equal periods.

or

- c) Local status certificate issued by MRO for claiming as AP local as per Circular Nos.4136/SPF&MC/2015-5, dated.08.08.2016 and 4136/SPF&MC/2015-13, dt. 20.11.2017.

EXPLANATION: (for purpose of this sub-regulation)

- i) "Educational Institution" means a University or any Educational Institution recognized by the State Government, a University or any other Competent Authority.
- ii) Relevant qualifying examination in relation to admission to any course of study means the examination, a pass in which is the minimum educational qualification for admission to such course of study.

NOTE: The relevant qualifying examination for admission into MDS courses is BDS examination. The question whether the candidate is a local candidate or not will be determined with reference to his/her first appearance in the Final BDS examination.

- iii) a) In reckoning the consecutive academic years during which a candidate has studied any period of interruption of his/her study by reasons of his/her failure to pass any examination and any period of his/her study in a Statewide University or a Statewide Educational Institution shall be disregarded.
- b) The local/non local status of candidates who passed BDS from Govt.Dental College, Vijayawada, Govt.Dental College, Hyderabad and Army College of Dental Sciences, Secunderabad will be decided basing on their study period prior to their admission into BDS course. The question whether any candidate for admission into any course of study has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of his/her parent or guardian

5.3 While determining the number of seats to be reserved in favour of local candidates under regulation (4), any fraction of seat shall be counted as one, provided that there shall be one unreserved seat.

5.4 If a local candidate in respect of a local area is not available to fill any seats reserved or allocated in favour of local candidate in respect of that local area such seats shall be filled in as if it had not been reserved.

5.5 The applicant who claims to be local candidate with reference to sub-regulation 5.2.1 or 5.2.2 shall produce in the form of study certificate/certificates issued by the Head of the Educational Institution/Institutions concerned indicating the details of the year or years in which the candidate has studied in educational institution in such local area for a period of not less than 4/7 consecutive academic years ending with the academic year in which he/she appeared or as the case may be first appeared for the Final BDS examination.

Those who did not qualify as local candidate under sub-regulation 5.2.1 and 5.2.2 but claim to qualify by virtue of residence shall produce a certificate issued by an officer of the Revenue Department not below the rank of Mandal Revenue Officer independent charge of Subtaluk / Mandal in the form annexed to G.O.P.No.628, Education dated 25-7-1974.

5.6 The following categories are eligible to apply for admission to the remaining 15% of Unreserved seats.

5.6.1 As per G.O.Ms.No.101, HM&FW (C1) Dept., dt.15-07-2023 of Govt. of A.P, the following categories of candidates are eligible under 15% of the available un-reserved seats in the colleges established before 02.06.2014:

- a) All Local candidates defined in the Presidential order.
- b) Candidates who have resided in the State for a total period of ten years excluding periods of study outside the State or either of whose parents have resided in the State for a total period of ten years excluding periods of employment outside the State. (Annexure -III (a) – for student) & Annexure – III (b) – Parent Residence)
- c) Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporation, Local Bodies, Universities and other similar quasi Public Institution within the State; and (Annexure-III (c)).
- d) Candidates who are spouses of those in the employment of the State or Central Government Public Sector Corporations, Local Bodies, Universities and educational institutions recognized by the Government or University or other competent authority and similar other quasi Government institutions within the State. (Annexure-III (c))

N.B.: The Scanned copies of relevant certificates must be uploaded for verification along with online application. In respect of residence certificate, the certificate should be obtained from the Revenue authorities clearly specifying the years.

5.6.2 As per G.O.Ms.No.101, HM&FW (C1) Dept., dt.15-07-2023 of Govt. of A.P, the following categories of candidates are eligible to apply for admission under 15% of the available un-reserved seats for the colleges established and for the seats increased in the State of Andhra Pradesh after 2nd June, 2014.

- a) All the candidates eligible to be declared as local candidates of two local areas of State of Andhra Pradesh.
- b) Candidates who have resided in the State of Andhra Pradesh for a total period of 10 years excluding periods of study outside the State or either of whose parent have resided in the State of Andhra Pradesh for a total period of ten years excluding period of employment outside the State.
- c) Candidates who are children of parents who are in employment of the State of Andhra Pradesh or Central Government, Public Sector Corporations, Local Bodies, Universities and Educational Institutions other similar quasi Public Institutions within the State of Andhra Pradesh

- d) Candidates who are spouses of those in the employment of the State of Andhra Pradesh or Central Government, public sector corporations, Local Bodies, Universities and Educational Institutions recognized by the Government or University or other Competent Authority and similar quasi Government Institutions within the State of Andhra Pradesh.”

NOTE: Relevant scanned original certificates must be uploaded along with application in respect of their claim for 15% Unreserved seats. In respect of proof of 10 years residence, the certificate should be obtained from the Revenue Authorities and the issuing Officer shall not be below the rank of Mandal Revenue Officer / Tahsildar

6. SERVICE CANDIDATES:

Note: Service rendered up to **30-06-2023** will be considered for considering the candidature under Service Category seats.

- (i) If a candidate has already completed PG Degree before joining Government Service, he/she will not be given deputation to do another PG Degree. If a candidate has done PG Diploma course before joining Government Service or after joining Government Service, if he/she is selected for a PG Degree, he/she will be given deputation for 12 months only.
- (ii) In-service candidate shall join the course on or before the commencement of the course after getting relieved from the concerned Head of the Institution. The Heads of the Medical Institutions shall relieve them if they apply for relief enclosing a copy of the selection and allotment order issued by the Competent Authority.
- (iii) All candidates who are In-service seeking admission into PG Courses shall submit application forms with details of service rendered by them in the proforma as per Annexure-IV-A.
- (iv) In-service candidates shall submit service certificate issued only by the concerned Directorate/ Commissionerate in the prescribed form appended as Annexure IV-B.
- (v) As per G.O.Ms.No.150, dt.11-12-2021 of HM&FW(C1) Dept., Government of A.P, the following are the rules for implementing reservations in case of In-service candidates:
- Out of 50% of the seats in State Government quota, 30% of clinical & 50% of non-clinical seats will be exclusively allocated to in service candidates serving in Government Health Institutions in the State of Andhra Pradesh.

As per G.O Ms.No.206, dt.11-08-2022 of HM & FW (C1) Dept., Government of AP, the following rules shall be followed:

- In Tribal areas: Minimum 2 (two) years of regular and continuous service in PHCs/CHCs/Area Hospitals/District Hospitals/Sample Survey cum assessment units/Leprosy temporary hospitalization wards & any Tribal Institute recognized by Government of Andhra Pradesh.

- In Rural areas: Minimum 3 (three) years of regular and continuous service in PHCs/CHCs/Area Hospitals/District Hospitals/MCH/Sample Survey cum assessment units/Leprosy Control Units/Leprosy temporary hospitalization wards/Mobile Medical Units & any Rural Institute recognized by Government of Andhra Pradesh.
- Minimum 6 (six) years of continuous regular service in AP Medical&Health Services/APVVP/AP Insurance Medical Services/University of Health Sciences.

Other conditions governing the In-service candidates:-

- Deputation to in-service candidates selected shall be restricted to 3/2 years only i.e., 36 months/24 months for PG Degree & Diploma Courses respectively. The in-service candidates selected to prosecute Post Graduate courses shall be sanctioned deputation for one course only in his/her service time.
- In case, if a In-service candidate is selected for PG Diploma Course the candidate may be given deputation, if the candidate is otherwise eligible for a period of 2 years. If a In-service candidate having a PG Diploma either before entry into Govt. Service or after entry into Govt. Service is selected for a PG degree in any specialty, he/she shall be allowed deputation for another period of 12 months only. No candidate shall be allowed deputation for studying 2nd Post Graduate Diploma course under In-service quota.
- In-service candidates shall join the course on or before the commencement of the course after getting relieved from the concerned Head of the Institution. The Heads of the Medical Institutions shall relieve them if they apply for relieving duly enclosing a copy of the Allotment Order issued by the Chairman, Selection Committee.
- After completion of specialization, the in-service doctors to be available to serve in Government facilities in the same area (Tribal/Rural/Continuous regular service) from where the reservation was sought, to a minimum of six (6) years, subject to the availability of vacancies in respective specialities, through a bond as per proforma (Annexure-B) as per G.O.Ms.No.252, dt.07-10-2022 of HM&FW Dept. of Govt. of Andhra Pradesh i.e.,

The University shall cancel the PG (Dental) Degree/Diploma of the candidate and the penalty of indemnity bond shall be Rs.25 Lakhs for non-rendering of services after completion of such course for In-service candidates.

The maximum duration to complete MDS is six (6) years from the date of admission including University examinations. The maximum duration to complete PG (Dental) Diploma is four (4) years from the date of admission including University Examinations.

7. RESERVATIONS:

- 7.1 Seats of Post Graduate Dental Degree and Diploma Courses are reserved for SC, ST and BC and BC sub groups as detailed below, which are called vertical reservations.

- 7.2 Candidates claiming reservations under SC/ST/BC categories shall submit a permanent social status certificate issued by Government of Andhra Pradesh/Telangana. The social status of SC/ST/BC candidates shall be subject to the scrutiny as per G.O.Ms.No.58 SW (J) Dept. Dt 12-5-97.
- 7.3 Seats of Post Graduate (Dental) Degree and Diploma Courses as per DCI/Govt. of India, New Delhi guidelines shall be reserved for the following categories of candidates, which are horizontal reservations:

Reservations to Women Candidates - 33 1/3%

Reservations to PwBD Candidates - 5%

7.4 RESERVATIONS UNDER PwBD CATEGORY:

1. There will be 5% Horizontal reservations for PwBD candidates
2. The candidates seeking the benefit of reservation under PwBD category should enclose a valid disability certificate issued not later than three months(03) prior to submitting his/her application.
3. The guidelines of Govt. of India and regulations of National Medical Council shall be observed in making admissions under PwD category.
4. The Medical Board constituted by the University will scrutinize/verify the disability certificates as per G.O.MS.No.31, Women development, Child welfare & disabled welfare (DW) department, dated.01-12-2009 and candidates claiming reservation under PwBD quota for confirmation of eligibility and the decision of Medical Board specially constituted for the purpose is final and binding on the candidates.

- 8.2** The candidates are advised to take a print out of the Prospectus / Instructions from the website <https://drysr.uhsap.in> before proceeding to fill the application form.
- 8.3** The candidate should fill the online application form available on the Website with the data required-for, through internet. The online application form can be filled through any computer with internet connection. The candidate is advised to fill the online application form after going through the Prospectus by keeping all the Certificates ready to enter his/her correct data.
- 8.4. Procedure of filling online application form and payment of fee through online:**
- a. The fee can be paid through Debit card/Credit card or Net Banking.
 - b. The fee paid by the applicants is not refundable under any circumstances.
 - c. Read the Notification, Prospectus/Regulations carefully regarding eligibility under local and non-local.
 - d. The Registration number which will be sent to the registered mobile after entering the basic details, should be noted for further use. The Registration number should be kept confidential and should not be disclosed to others.



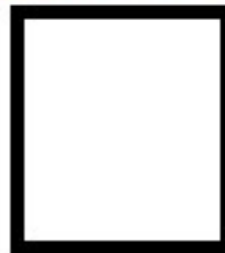

8.5 The Registration & Processing fee including 18% GST :

1. OC & BC Candidates – ₹.7,080/- (6,000/- + 1,080/- GST 18%)
(Registration fee ₹. 3,500/- + 630/- GST 18% & Processing fee ₹.2,500/- + 450/- GST 18%).
2. For SC & ST Candidates – ₹.5,900/- (5,000/- + 900/- GST 18%)
(Registration fee ₹. 3,000/- + 540/- GST 18% & Processing fee ₹.2,000/- + 360/- GST 18%).

Verification Fee: In addition to the above said Registration & Processing fee:

1. The candidates who acquired their BDS Degree outside the AP/TS State shall pay ₹.3,540/- (i.e., ₹.3,000/- + 540/- GST 18%)
 2. The candidates who acquired their BDS Degree in Abroad/Foreign Country shall pay ₹.8,260/- (i.e., ₹.7,000/- + 1,260/- GST 18%)
- The fee can be paid through Debit card / Credit card or Net Banking
 - **The verification fee, registration fee and processing fee once paid will not be refunded or adjusted under any circumstances. Therefore, candidates are advised to check eligibility conditions thoroughly before applying for admission into PG Medical courses. Application form once submitted cannot be withdrawn and fee paid shall not be refunded/adjusted.**
 - The selected candidates have to download the Allotment order by paying an amount of University fee of Rs.23,600/- through online mode.

8.6 The candidates are advised to submit a printout of filled in online application form duly signed at the declaration area at the reporting college.

9. **MERIT LISTS:**

- The merit position of the candidates applied shall be determined basing on NEET-MDS-2023 Ranks and as per their eligibility.
- After completion of the verification of data and certificates uploaded by the candidates, the University will release final merit position of the candidates eligible for exercising Web options.
- Candidates who are included in the final merit list will only be eligible for exercising web Options.

10. **Allotment of Seats:**

- Further, the Orders, if any, as amended from time to time by the Government of Andhra Pradesh/Dental Council of India/Government of India are applicable.

11. ADMISSION RULES:

11.1 The cutoff date for reporting at the allotted college by the selected candidates will be communicated in the allotment order.

11.2 All the candidates including service candidates joining the Post Graduate Degree/ Diploma courses should execute bond on a stamped paper of Rs.100/- value as prescribed in Annexure-III to the effect that he / she will complete the prescribed period of training in the event of leaving the course, the candidate has to pay Rs.3,00,000/- + 18% GST to the University and shall also refund the amount received as stipend upto that date to the Government as notified by the University from time to time.

11.3 As per G.O.Ms.No.67, HM&FW (C1) Department dated 21-04-2017, candidates have to pay the discontinuation penalty of Rs. 3,00,000/- + 18% GST and they will be debarred for three years for admission into Post Graduate Dental Degree/Diploma courses at the colleges in the State of Andhra Pradesh for admission into PG Dental courses subject to receipt of orders from the Government if any and as notified by the University from time to time.

11.4 ATTENDANCE: Candidates selected for the various courses should be the whole time students. The candidate is required to put in a minimum of 80% attendance during each calendar year for being eligible to appear for the examination. In a year all 365 days will be considered as working days and students should get 80% attendance each year separately to get eligibility for appearing for University exams. The remaining days of absence (including maternity leave) will be considered for extension.

11.5 LEAVE: Students will be permitted to avail 30 days leave per year. No Post Graduate is allowed to go on leave more than 8 days at a stretch. In case the absence of the candidate availing Medical Leave / Maternity Leave / Any other Leave or unauthorized absence is beyond 30 days in a year, the study period of the candidate will be extended to the extent of such period. No other leave is permitted.

11.6 MATERNITY LEAVE: Women students can avail maternity leave up to 120 days only once in their PG course of study and the study period will be extended to the extent of Maternity leave availed. The candidate shall not be eligible to appear in the University examinations till the completion of study period as per DCI Regulations (Duration of course).

11.7 BREAK OF STUDY AND RE-ADMISSION: If a student is absent continuously for a period of 91 days or more and seeks permission to attend the course, his / her application in prescribed format vide annexure V & VI along with requisite fee through DD drawn in favour of Registrar, Dr YSR University of Health Sciences payable at Vijayawada shall be forwarded to the Registrar, Dr.YSR University of Health Sciences with the recommendation of the Principal. The candidates are advised to refer the regulations before submitting the application and paying the fee. If they fulfill the conditions, they may submit applications through the Principal of the College by paying the fee.

11.8 **PRIVATE PRACTICE:** No Post Graduate is allowed to do any private practice or consultation and should not accept any part time employment in any State or Central or Quasi Government or Private organizations during the period of Post Graduation study. The Principal has to take appropriate action after giving opportunity for explanation, if any student violates this rule.

12 COLLEGE REGULATIONS: Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Under no circumstances they should have any correspondence with the higher authorities directly without routing through proper channel.

12.1 Deputation to in-service candidates selected under service quota shall be restricted to 3 years only i.e., 36 months. The candidates selected to prosecute Post Graduate courses under in-service quota shall be sanctioned deputation for one course only in his/her service time. The candidate selected under in-service quota shall be permitted to take any course of his/her choice based on merit.

12.2 In-service candidates shall join the course on or before the closure of the admission after getting relieved from the concerned Head of the Institution. The Heads of the Institutions shall relieve them if they apply for relief enclosing a copy of the allotment order issued by the Chairman, Selection Committee.

13. CLOSURE OF ADMISSIONS:

13.1 The admissions shall be closed on the date notified by the University.

13.2 Any vacancy as on the date (or) after the date of closure of admissions shall not be filled. They will not be carried forward to the next year as per the directions of Supreme Court of India.

14. COMMENCEMENT OF THE COURSE:

The course shall commence as per the schedule notified.

15. DURATION OF COURSE:

The duration of P.G. Diploma courses is 2 years and P.G. Degree courses is 3 years from the date of commencement of the course including University Examinations. In case of students having a recognized two year Post Graduate Diploma course in a subject selected for PG Degree in the same subject, then the period of training including the period of examination, shall be two years. If the break of study is more than three months the candidate has to apply (vide Annexure-VI) to the University through the Principal/Dean of the college. The University can give permission to the candidate to complete the course as per Rules based on evidences produced by the candidate for the break of study.

16. DISSERTATION:

The Post Graduates who are admitted in Degree / Diploma Courses must register the topic of their dissertation with the University within six months of commencement of the course and approval of the University should be obtained.

The dissertation should be submitted within 2 ½ years of commencement of the Course. In case of the candidates who are granted exemption of one year of study period of degree course, the dissertation should be submitted within 1 ½ years of commencement of the course. If the above schedule is not followed the period of Post Graduation will be extended by six months.

- The UGC Notification, dt.23-07-2018 published in the Gazette of India regarding “Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions, Regulations 2018” are in force from the academic year 2021-22.

17. Paper Presentation/Paper publication should be as per DCI Regulations.

18. MIGRATION AND TRANSFER OF CANDIDATES:

Migration / Transfer / Mutual transfer of Post Graduate students from one Dental college to another Dental College, from one course to another course and from Degree to Diploma and vice versa is not allowed under any circumstances.

19. POWERS OF PRINCIPALS:

Notwithstanding anything contained in these regulations, the Principals of Dental Colleges in the State may at any time before completion of the post graduate course either on their own or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit written explanation and on personal hearing, order, cancellation of admission to the 1st year Post Graduate Degree / Diploma course if in the documents attached thereto or in the Statements made either before the authority in charge of admission or the Principals or in any other manner. Against any such order of the Principal, an appeal shall lie with the Registrar, Dr. YSR University of Health Sciences, A.P. Vijayawada.

20. POWERS OF Dr. YSR UNIVERSITY OF HEALTH SCIENCES:

Dr. YSR University of Health Sciences, Vijayawada may either suo motu or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation thereto as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation. Dr. YSR UHS has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake/false/forged.

Note: If a candidate is found to have submitted false information such candidate is liable to be disqualified for admission and in case already admitted, the admission will be cancelled. Further disciplinary action against him/her will be initiated by the University as per rules.

21. RAGGING:-

The candidates who join MDS Courses should not indulge in any kind of agitation / strike / ragging activity inside / outside the college campus during the course of study. The candidates if found to take part in any such activities mentioned above will be expelled from the course / college at any part of the course of study and legal proceedings / criminal action will be initiated against them. A copy of the National Medical Commission (Prevention and Prohibition of Ragging in Medical Colleges and Institutions) Regulations, 2021 is also available in University website for information.

22. The candidates applying for MDS Degree Course for the academic year 2023-24 are deemed to have read the contents in the Prospectus and agree with all conditions / clauses and will not have the right to challenge any of the clauses contained in the Prospectus and agree that the same is binding upon them.

FREQUENTLY ASKED QUESTIONS (FAQs)

Q. No. 1: When will PG(Dental) Allotments start for State Quota (also called Competent Authority Quota) seats?

Ans: The schedule will be as per MCC/DCI, New Delhi guidelines and you have to visit University Website regularly for updates.

Q. No. 2: Is a candidate required to report to any center for online Registration and Web options?

Ans: The entire process is online only. Not required to report at any center for Registration and Web options

Q.No.3. Is one online application is sufficient for both SQ/CQ and Management Quota seats?

Ans: Separate applications are required to be submitted for SQ/CQ and MQ seats. Visit University website for SQ/CQ and MQ Notifications.

Q.No.4: What is the cut-off date of Internship?

Ans: 30th June-2023 is the cut-off date for Internship.

Q. No. 5: What is the mode of reporting at the allotted college. Do I have to report personally at the allotted College?

Ans: The allotted candidate has to download the allotment letter by paying Rs.23,600/- through online mode. Candidates who are allotted seats should report at the allotted colleges along with all **Original Certificates, allotment letter and Provisional Verification Form** on or before the last date mentioned in the Allotment letter.

Q.No.6: What is the process of Web options?

Ans: A candidate has to opt for the interested specialties and colleges before commencement of each phase of counselling as and when the Notification is released by Dr.YSR UHS, Vijayawada.

Q. No. 7: Is there any restriction for filling the number of web options?.

Ans: One candidate can give any number of web options. However, the candidates are advised to exercise web options for the course in which they are really interested to join.

Q. No.8: Is it necessary to join in allotted seat of Phase-I to get chance to participate in Phase-II?

Ans: If a candidate does not report at the allotted institute in Phase-I, this will be considered as 'Free Exit' (**this facility is available only in Phase-I**). Candidates who have not joined the Phase-I allotted seat may participate again in Phase-II.

However, if satisfied with the seat allotted in Phase-I, it is not required to participate in further rounds. Rules on Retain and Exit option will be issued in detail in the Notification. Candidates shall go through the Notification carefully.

Q. No. 9: Will I get any personal intimation regarding schedules and allotments?

Ans: No. The candidates have to visit University website regularly for notifications/schedules

Q. No. 10: Can I modify my web options during the choice submission for counseling?

Ans: Yes, you can modify, add or delete your web options before you submit your web options. However, once web options are submitted, they cannot be modified later under any circumstances.

Q. No. 11: I have not submitted my web options before the time specified in counseling schedule, what will happen to my web options?

Ans: The web options already saved by you will be considered automatically and the web options cannot be altered/modified/changed.

Q.No.12: Who are eligible for exercising web options in Phase-II

Ans:

- a) Candidates who participated in Phase-I, but did not get any seat allotted in the Phase-I.
- b) Candidates who have reported/joined in the allotted seat of Phase-I
- c) Candidates who have not reported/joined in the allotted seat of Phase-I

Q. No. 13: If sufficient number of qualified PwBD candidates are not available then, what will happen to those un-allotted PG seats, reserved for PwBD candidates?

Ans: The un-allotted PG seats earmarked for PwBD will be reverted/converted to respective categories of same area as PwBD reservations are Horizontal reservations only.

Ex: BC-A – PwBD (G) to - BC-A (G)
SC - PwBD (F) to - SC (F)

Q. No. 14: Will I get any personal intimation regarding schedules and allotments?

Ans: No. The candidates have to visit University website regularly for notifications/schedules

Q.No.16: What is MRC (Explain with example)?

Ans: Meritorious Reserved Candidate-MRC

Example:

- In a particular college MDS(Conservative Dentistry) seat is under “Open Category” in the seat matrix and a SC candidate is allotted that Open Category MD(Conservative Dentistry) seat in Open Round Counselling of Phase-I as per his/her web options and NEET -MDS Rank merit order of the candidate. Now this candidate is shown as **Meritorious Reserved Candidate (MRC)**.
- The same SC candidate has slid to MD (Prosthodontics) SC category seat in the same college or another college during the Category Round of Phase-I Counselling **conducted on the same day**, then that MD(Conservative Dentistry) seat vacated by this MRC candidate shall be filled with the SC candidates only by merit amongst them.
- This type of MRC concept is to be followed for all BC/SC/ST categories in order to maintain 50 : 50 ratio of Open : Category Reservation
