NOTIFICATION FOR EXERCISING WEB OPTIONS FOR PHASE-I COUNSELLING FOR BOTH SERVICE AND NON-SERVICE CANDIDATES FOR ADMISSIONS INTO THE COMPETENT AUTHORITY QUOTA (CQ) SEATS OF POST-GRADUATE MEDICAL DEGREE/DIPLOMA COURSES AVAILABLE IN THE GOVERNMENT AND PRIVATE NON-MINORITY AND MINORITY MEDICAL COLLEGES AFFILIATED TO Dr.YSR UHS AND SVIMS, TIRUPATI FOR THE ACADEMIC YEAR 2023-2024.

In continuation to this Office Notification, dt.21-07-2023, Dr.YSR UHS, Vijayawada hereby notifies the schedule for exercising Web Options for Phase-I of counselling for both **Service and Non-service candidates** for admissions into Competent Authority Quota (CQ) PG Medical Degree/Diploma courses available in the Government and Private Non-Minority and Minority Medical Colleges under Dr.YSR UHS and SVIMS, Tirupati for the academic year 2023-2024 for the seats available in the following colleges:

- a) Seats available (after contributing 50% of seats to All India Quota) in Government Medical Colleges in the State of Andhra Pradesh, affiliated to Dr. YSR UHS.
- b) Category- A Convenor Quota seats (50% of Intake) in Private Un-aided Non-Minority and Minority Medical Colleges in the State of Andhra Pradesh, affiliated to Dr. YSR UHS.
- c) 53 seats in SVIMS, Tirupati.

UNIVERSITY FEE: Candidates to whom seat is allotted have to pay Rs.23,600/- for downloading allotment letter. The payment is to be paid through payment Gateway <https://pgcq.ysruhs.com/> by using Online payment method. (Debit Card/Credit Card/Internet Banking).

Instructions to Candidates:

1	Area wise Seat Matrix is displayed in the University Website for information of the candidates to exercise their Web options.
2	<p>Candidates are advised to go through the Prospectus (placed in the University website on 21-07-2023) and the Government Orders on Rules of PG admissions available before exercising web options. Candidates are also advised to go through the details about “MRC” concept which is exemplified below:</p> <p>Example:</p> <p>a) In a particular college MD(RD) seat is under “Open Category” in the seat matrix and a SC candidate is allotted that Open Category MD(RD) seat in Open Round Counselling of Phase-I as per his/her web options and NEET Rank merit order of the candidate. Now this candidate is shown as Meritorious Reserved Candidate (MRC).</p> <p>b) The same SC candidate has slid to MD (General Medicine) SC category seat in the same college or another college during the Category Round of Phase-I Counselling conducted on the same day, then that MD(RD) seat vacated by this MRC candidate shall be filled with the SC candidates only by merit amongst them.</p> <p>c) This type of MRC concept is to be followed for all BC/SC/ST categories in order to maintain 50 : 50 ratio of Open : Category Reservation</p> <p>d) G.Os governing MRC and other regulations:</p> <ol style="list-style-type: none"> 1. G.O.Ms.No.43, HM&FW (E1) Dept., dt.13-03-2013 2. G.O.Ms. No.88, HM & FW (E1) Dept., dt. 21-05-2014 3. G.O.Ms. No.68, HM & FW (C1) Dept., dt. 21-04-2017 4. 3	Candidates opting for Medical Degree/Diploma courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of subjects and colleges if the candidate is interested to join as per eligibility.
4	Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are really interested. If they are not interested to join any subject or college then they should not exercise options for the same.
5	<p>Candidate can exercise web options from any place having internet facility One Time Password will be sent to the registered mobile number at the time of saving Web options.</p> <p>I) Selected Options can be slid either up or down, added and deleted.</p> <p>II) Web options opted must be saved by the candidate.</p> <p>III) Web options once submitted can not be Edited.</p> <p>IV) Web options saved but not submitted until the cut off date and time will be Auto submitted.</p>
6	The selected candidates can download the provisional allotment letter on payment of University Fee of Rs.23,600/- through payment gateway https://pgcq.vsuhs.com/ and report to the Principal of the Allotted College on or before the date specified in the allotment letter.
7	The selected candidates shall produce all the Original certificates, pay the Tuition fee, necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
8	The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated.

9	<p>Eligibility for Exercising web options in Phase-II Counselling</p> <p>The following candidates are eligible:</p> <p>a) Those candidates who have been not allotted any seat in this Phase-I counselling.</p> <p>b) Those candidates who have been allotted a seat in this Phase-I but not reported/not joined/ exited from allotted seat at the allotted colleges. However if a candidate has not joined/reported in the allotted seat of Phase-I then that particular seat shall not be available for that candidate to exercise web options in Phase-II counselling.</p> <p>Mop Up Round:</p> <p>a) Candidates who have exercised/participated for web options in Phase-I & Phase-II but not allotted any seat are eligible for Mop Up round.</p> <p>b) Candidates who have not exercised/participated for web options in any phase are not eligible for participating in Mop Up round.</p>
10	<p>Candidates who have resigned from the Phase-I reported seat before the due date as per the schedule will be considered as not reported/not joined and such vacated seats will be filled in Phase-II counselling as per rules. After the due date, all Phase-I reported candidates will be considered as a part of Phase-II and same rules will apply on them as applicable for Phase-II of counselling and cannot resign the seat.</p>
11	<p>The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated. If the candidate slides to other college (i.e., affiliated colleges of Dr.YSR UHS) during subsequent Phases of counselling the tuition fee already paid will be transferred to the slided college by the concerned college where the amount is held.</p>
12	<p>Upgradation of candidates after Phase-II is not allowed in view of Supreme Court Orders, dt.22-07-2022 in Contempt Petition (Civil) No.289 of 2022 in W.P. (CIVIL) No.223 of 2022.</p>
13	<p>As per G.O.Ms.No.67, dt.21-04-2017 in the final phase of final counselling:</p> <p>A candidate who exercised web options and joined in an allotted seat shall not be permitted to withdraw from the seat. In case any candidate withdraws from the allotted seat, the candidate shall be debarred for a period of three years for admission into Post Graduate Medical Degree/Diploma courses at the colleges in the State of Andhra Pradesh besides payment of Rs. 3,54,000/- (including 18% GST).</p>
14	<p>As per the National Medical Commission, New Delhi, Letter No.N-P018(20)/5/2023-PGMEB-NMC/044351, dt.24-07-2023 the Stray vacancy round for the seats if any available at the end of Mop Up round(s) in all Government and Private Medical Colleges including Minority Medical Colleges affiliated to Dr.YSR UHS and SVIMS, Tirupati shall be conducted by Dr.YSR UHS in online mode from the academic year 2023-24</p>
15	<p>The University fee and other fee once paid shall not be refunded under any circumstances.</p>
