Notification for exercising web options for 2nd Phase of web based counselling for admission into BDS Course under Management Quota Seats for the academic year 2020-21.

In continuation of earlier notifications dated 19.12.2020 the University hereby notify the 2nd Phase of web based counselling for the BDS seats available under Management Quota (Category B & Category C (NRI)) in Private Un-aided Non-Minority Dental Colleges (under Dr. NTR UHS) for the academic year 2020-21 in the state of Andhra Pradesh.

Details of Seats:-

The Unfilled seats of earlier counseling, Vacancies arising due to non - joining and vacancies arising during the process of counseling. List of college wise vacancies are displayed in the University website.

All the eligible candidates whose names are present in the Provisional Final Merit list for admission into Management Quota Seats which was displayed on the University Website on 19-12-2020 can exercise their web options:

From <u>8.00 AM on 09.01.2021</u> to <u>3.00 PM on 09.01.2021</u> in the website https://appvtmedadm.apntruhs.in as per their eligibility for the seats available under Management quota (Category B and Category C (NRI)) for BDS course. Both Category B and Category C (NRI) seats available in Private Unaided Non-Minority Dental colleges will appear to the candidates who are found eligible for Category C (NRI) seats. Such candidates have to exercise web options carefully as per their priorities category wise /college wise. The allotments will be as per the prioritized options exercised by the candidates.

The candidates who have taken BDS seats under Management Quota in earlier counseling are eligible for exercising options in this 2nd Phase of counseling, if they wish to slide to other college or to other category. The candidates are also eligible to slide from category 'C' to category 'B'.

The candidates who have not joined in the allotted college in the 1st counselling are not allowed to opt the same college.

The candidates who were admitted in MBBS/BDS courses under AIQ / MBBS course in Telangana State and MBBS course under Competent Authority quota & Management Quota in the Medical Colleges in AP are NOT eligible to participate in this Counseling. If any candidate violates this and noticed by the University at any stage during the course of BDS such candidate is liable for punishment including cancellation of the seat / admission.

Candidates who were joined in BDS course in any phase of counselling are not eligible for Mop-up round counselling except the candidates admitted in Category C (NRI) seats who will be allowed to opt to slide to Category B seats only.

The selected candidates have to download the allotment order by paying the following University fee through Payment Gateway by using online payment method. (Debit Card /Credit Card / Internet Banking) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the order and pay the prescribed tuition fee at college.

<u>Instructions to Candidates:-</u>

- 1. Eligible Candidates as per Provisional Final Merit list for Management Quota can exercise web options for Management Quota BDS seats in all Dental colleges as per their interest and priority.
- 2. Candidates are advised to go through the prospectus for the regulations of Dr. NTR UHS available on website before exercising web options.
- 3. The candidates who have not exercised options in 1st phase counseling are eligible to exercise web options.
- 4. The resultant vacancies will be added to the vacancies and filled
- 5. Candidates are advised to exercise options for BDS seats in colleges in which they are interested to join. If they are not interested to join in BDS course or college, then they should not exercise options for the same.
- 6. Candidates have to exercise options for B category and C Category (NRI), if eligible, in order of priority for course and college. Allotments will be made according to the order of priority in the web options exercised by the candidate.
- 7. A candidate can exercise any number of options.
- 8. Candidates are instructed to take the print out of the saved options.
- 9. Candidate can give options on the web either from home or any other place having internet facility. Do not use mobiles and tablets to exercise the options. Use only computers. Use Internet Explorer Version 11 for exercising web options.
- 10. Candidates are instructed to be careful while exercising options on the web.

 One Time Password will be sent to the registered mobile at the time of saving web options. The password consists of SIX letter code with English capitals A to Z.
- 11. Candidates will instructed to verify the https://appvtmedadm.apntruhs.in and also University website for allotment status and download the provisional allotment order by paying the university fee through netbanking.
- 12. Candidates are hereby informed that final verification of original certificates will be conducted at the college at the time of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.
- 13. Selected candidates have to report to the Principal of the allotted college before the last date for joining as specified on the allotment letter with all original certificates, undertaking, NRI documents, if any and pay the tuition fee and college fee to complete the process of admission. If the candidate fails to report before the reporting date and time, the admission will be cancelled automatically.
- 14. If the candidate does not fulfil the above criteria to complete the admission process within specified date for joining, the admission will be cancelled automatically.
- 15. Original certificates will not be returned to candidate, unless the candidate discontinues the course or slides to other college in this phase of counseling or allotted a seat in colleges affiliated to Dr. NTR UHS, Vijayawada.

- 16. A candidate who joins in a college and withdraw from the course and again re-join and wants to withdraw in 2nd phase also, a penalty of 25% of Tuition Fee fixed for that category is imposed on such candidates which is to be paid to the University.
- 20. Candidates will have to pay discontinuation penalty amount as per Government orders, if they discontinue the course after the cut off date as notified for free exit from Management Quota seat or during the course to get their original certificates back.
- 21. The University fee once paid shall not be refunded under any circumstances.
