**NOTIFICATION FOR EXERCISING ONE TIME WEB OPTIONS FOR MOP UP ROUND OF COUNSELING FOR THE VACANT SEATS OF POST-GRADUATE MEDICAL DEGREE/DIPLOMA COURSES UNDER Dr. YSR UHS FOR STATE QUOTA/COMPETENT AUTHORITY QUOTA SEATS IN GOVERNMENT AND PRIVATE NON-MINORITY AND MINORITY MEDICAL COLLEGES FOR THE ACADEMIC YEAR 2022-23.**

**Note:** OCI/PIO/Foreign Nationals will only be eligible for NRI seats and not for Indian (All India Quota/Central/Deemed paid (Indian) seats for the current academic year. For complete details refer Notice Ref.U-12021/01/2022-MEC, dt.22-09-2022 of DGHS, Govt. of India, New Delhi.

Eligible **Non-Service candidates** whose names are in the Final Merit Position notified in the University Website are only eligible to exercise web options as per the above dates.

**INSTRUCTIONS**

**Note: One time Web options exercised by the candidates for this MoP Up Round will also be considered for further additional MoP Up Rounds if any conducted by Dr.YSR UHS for State Quota/Competent Authority Quota seats.**

1. Eligible **Non-Service candidates** whose names are in the Final Merit Position notified in the University Website are only eligible to exercise web options as per the above dates and according to the Seat Matrix displayed in the University Website <http://ntruhs.ap.nic.in>.
2. Candidates who have not been allotted any seat in any Phase-I/Phase-II of SQ/CQ counsellings **are eligible** to exercise web options for PG Medical Courses.

**NOT ELIGIBLE CANDIDATES:**

1. Candidates holding any seat in any college **through out the country** are not eligible to participate in the Mop Up round
2. Candidates who were allotted any seat either in Phase-I (or) Phase-II of State Quota/Competent Authority Quota seats are not allowed to participate in Mop Up round.
3. Allotted candidates of Phase-I/Phase-II Management Quota of Andhra Pradesh State are not eligible.

4. Candidates who have been allotted but not reported in Phase-I/Phase-II of SQ/CQ counsellings of Andhra Pradesh State are **not eligible**.
5. Candidates who have joined PG (Medical) seat in All India Quota /Any State/Deemed Universities (Including KNR UHS, TS) counsellings are not eligible for this MOP UP Round. If any candidate violates this and noticed by the University at any stage then the candidate is liable for punishment and his/her admission will automatically stands cancelled.
6. Candidates who have discontinued the course after joining in any phase of State Quota/Competent Authority Quota Seats are **not eligible**.
7. **IMPORTANT NOTE: Candidates if allotted any seat in this MOP UP Round should compulsorily join the course and they will not be permitted to withdraw from the course. As such they are advised to give options to the courses for which they are really interested to join so as to give chance to next meritorious candidates.**
8. Vacancy position i.e., Un-filled and Not reported seats are displayed in the University website. Hence, the candidates are therefore advised to exercise options for all the seats in all the colleges as per their priority irrespective of vacancies.
9. Candidate can download the provisional allotment order on payment of University fee of Rs.23,600/- through payment gateway and report to the Principal of the allotted College on or before the date specified in the allotment order.
10. The University fee once paid shall not be refunded under any circumstances.
11. As per G.O.Ms.No.251, HM&FW (C1) Dept., dt.02-10-2022 each Non-service candidate admitted into PG (Medical) course from the academic year 2022-23 in State Quota/Competent Authority Quota seats in Government Medical Colleges/Private Medical Colleges shall execute a bond to serve the Government of Andhra Pradesh compulsorily in APVVP/DME, A.P Hospitals for a period of one year after completion of PG(Medical) Degree course. If they violate the bond condition either by not joining or by not completing the stipulated service period of one year within a maximum period of 18 months after completion of the PG (Medical) Degree course, a penalty of Rs.40,00,000/- (Rupees forty lakhs only) on PG (Medical) Degree candidates shall be levied. The Principals shall obtain a bond in the prescribed proforma.

**12. TUITION FEE FOR PG MEDICAL:** The following is the **Tuition fee structure** to be payable for the State Quota seats in Private Un-aided Non-minority and Minority Medical Colleges as per GO.Ms.No.56, HM & FW (C1) Department, dated 29-05-2020 of Government of Andhra Pradesh:

<b>Category of seat: Private Colleges (SQ/CQ seats)</b>	
Clinical Degree/Diploma	Rs. 4,32,000/-
Para Clinical Degree/Diploma	Rs.1,35,000/-
Pre Clinical Degree/Diploma	Rs.61,200/-

Note: The fee structure in Private Medical Colleges is as per G.O.Ms.No.56, HM&FW (C1) Dept., Dt.29-05.2020 and as per the directions of the Hon'ble High Court in W.P.No.10159 of 2020 and batch, dt.09-07-2020, which is read as "to permit the petitioners/students to pay fee fixed by the Regulatory authority by executing bond in the proforma prescribed by the Andhra Pradesh Private Medical and Dental Colleges Managements Association within the specified time as notified by Dr. YSR University of Health Sciences, Vijayawada".
